### **FREEDOM OF INFORMATION ACT 2000**

Thank you for your refined request for records of meetings between the Prime Minister's Office and 121Media between 1st January 2007 and 30th June 2007. The Cabinet Office received your request on 1 June 2009 and I have dealt with it under the terms of the Freedom of Information Act 2000.

I have carried out a search of our paper and electronic records and I have not found any information relevant to your request. I have therefore concluded that the Cabinet Office does not hold the information you seek.

The Cabinet Office has recently dealt with many requests on this subject and it may be helpful if I draw your attention to regulation 5 of *The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations, 2004* (SI 2004 No. 3244), made under Section 12(4) of the Freedom of Information Act. The regulations permit public authorities to aggregate two or more requests when calculating the cost of complying with requests in certain circumstances. These circumstances are where the requests are received from the same individual or from different individuals who appear to be acting in concert or in pursuance of a campaign; the requests relate, to any extent, to the same or similar information; and those requests are received within any period of sixty consecutive working days.

If you are unhappy with the decisions made in relation to your request from the Cabinet Office you may ask for an internal review. If you wish to do so you should contact:
