



## **Assessment of Moving Traffic Contraventions**

### ***Prohibited Manoeuvre (1)***

**Sign reference:** 612 TSR&GD 1994 – Failure to comply with a sign indicating a prohibited right turn.

This contravention deals with vehicles turning in a banned right direction.

#### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Prohibited Manoeuvre (2)**

**Sign reference:** 613 TSR&GD 1994 – Failure to comply with a sign indicating a prohibited left turn.

This contravention deals with vehicles turning in a banned left direction.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
  - b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
  - c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Prohibited Manoeuvre (3)**

**Sign reference:** 614 TSR&GD 1994 – Failure to comply with a sign indicating a prohibited U – turn.

This contravention deals with vehicles performing a banned U-Turn.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Mandatory Manoeuvre (1)**

**Sign reference:** 606 TSR&GD 1994 – Failing to drive in the direction indicated by a road sign.

This contravention deals with vehicles failing to turn in the direction indicated by an arrow.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the distance, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.,) must be kept by the EO and made available on request to authorised personnel.



## **Mandatory Manoeuvre (2)**

**Sign Reference:** 609 TSR&G Failing to drive in the direction indicated by a road sign.

This contravention deals with traffic failing to turn ahead as directed by a road sign.

### **Evidence required for the issue of a PCN**

- Evidence needs to show vehicle passing advance sign and then fail to make prescribed turn

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the advanced sign and passing it. As above for sign 606, suggest the advance sign be captured along with the vehicle approaching it, for approximately 20 metres. Both close up and contextual images required.
- b) The CCTV operator should follow the vehicle capturing the distance, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.,) must be kept by the EO and made available on request to authorised personnel.



## **Mandatory Manoeuvre (3)**

**Sign Reference:** 610 TSR&G Failing to comply with the directional requirements of a sign.

This contravention deals with traffic failing to pass a directional sign indicating passage to the left or right of the sign.

### **Evidence required for the issue of a PCN**

- Evidence needs to show vehicle failing to comply with the indication given by the sign to turn either left or right

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the sign and failing to pass as directed. As above for sign 606, suggest the advance sign be captured along with the vehicle approaching it, for about 20 metres. Both close up and contextual images required.
- b) The CCTV operator should follow the vehicle capturing the distance, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.,) must be kept by the EO and made available on request to authorised personnel.



## **Priority Manoeuvre (1)**

**Sign reference:** 615 TSR&GD 1994 – Failure to give way to oncoming traffic.

This contravention deals with vehicles failing to comply with oncoming traffic sign.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of 20 approximately metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **No Entry (With Associated Signs) (1)**

**Sign reference:** 616 TSR&GD 1994 – Failure to comply with a No Entry Sign.

This contravention deals with vehicles turning into a banned area.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## ***Restriction of Entry (1)***

**Sign reference:** 617 TSR&GD 1994 – Failure to comply with a sign indicating a prohibition of certain types of vehicle.

This contravention deals with certain types of vehicles entering an area where they are not allowed.

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## ***Restriction of Entry (2)***

**Sign reference:** 618.2 TSR&GD 1994 – Failure to comply with a sign indicating a restriction on vehicles entering a pedestrian zone.

This contravention deals with certain types of vehicles entering an area where they are not allowed - (all motor vehicles).

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## ***Restriction of Entry (3)***

**Sign reference:** 618.3 TSR&GD 1994 – Failure to comply with a sign indicating a restriction on vehicles entering a pedestrian zone.

This contravention deals with certain types of vehicles entering and waiting in an area where they are not allowed - (all motor vehicles).

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a prerequisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.,) must be kept by the EO and made available on request to authorised personnel.



## **Restriction of Entry (4)**

**Sign reference:** 618.3A TSR&GD 1994 – Failure to comply with a sign indicating a restriction on vehicles entering a pedestrian zone.

This contravention deals with certain types of vehicles entering and waiting in an area where they are not allowed - (with variable message sign).

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a prerequisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.,) must be kept by the EO and made available on request to authorised personnel.



## **Prohibited Vehicle Type (1)**

**Sign reference:** 619 TSR&GD 1994 – Failure to comply with a sign indicating a prohibition of certain types of vehicle.

This contravention deals with certain types of vehicles entering an area where they are not allowed – (motor vehicles).

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
  - b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.

## ***Prohibited Vehicle Type (2)***

**Sign reference:** 619.1 TSR&GD 1994 – Failure to comply with a sign indicating a prohibition of certain types of vehicle.

This contravention deals with certain types of vehicles entering an area where they are not allowed (motor vehicles except solo motor cycles).

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



### ***Prohibited Vehicle Type (3)***

**Sign reference:** 619.2 TSR&GD 1994 – Failure to comply with a sign indicating a prohibition of certain types of vehicle.

This contravention deals with certain types of vehicles entering an area where they are not allowed (solo motor cycles prohibited).

#### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Prohibited Vehicle Type (4)**

**Sign reference:** 622.1a TSR&GD 1994 – Failure to comply with a sign indicating a prohibition of certain types of vehicle.

This contravention deals with certain types of vehicles entering an area where they are not allowed (goods vehicles exceeding the gross weight indicated on the sign).

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## ***Prohibited Vehicle Type (5)***

**Sign reference:** 652 TSR&GD 1994 – Failure to drive in the direction shown by an arrow on a blue sign.

This contravention deals with vehicles failing to drive in the direction indicated by the sign.

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Bus / Tram Only (1)**

**Sign reference:** 653 TSR&GD 1994 – Using route restricted to certain vehicles.

This contravention deals with certain types of vehicles entering an area where they are not allowed (buses and pedal cycles only allowed).

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
  - b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
  - c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## ***Bus / Tram Only (2)***

**Sign reference:** 653.1 TSR&GD 1994 – Using a route restricted to certain types of vehicles.

This contravention deals with certain types of vehicles entering an area where they are not allowed (route for use by trams only).

### ***Evidence required for the issue of a PCN***

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### ***Method of Gathering Evidence:***

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area.
- b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **School Entrance Markings (1)**

**Sign reference:** 1027.1 TSR&GD 1994 – Stopped in a restricted area outside a school.

This contravention deals with part of the carriageway outside a school where vehicles should not stop.

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the sign and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a pre-requisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle approaching in the direction of the mandatory sign. Suggest the vehicle be followed for a distance of approximately 20 metres, shown to fail to comply with the sign and seen to continue on its route having failed to do so. Or, whether the vehicle parks, stops or traverses the restricted area causing congestion.
  - b) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
  - c) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.



## **Box Junction Contravention (1)**

**Sign reference:** 1043/1044 TSR&GD 1994 – Entering and stopping in a box junction when prohibited.

This contravention deals with vehicles entering a designated box junction when they are not permitted (unless turning right provided their exit is clear).

### **Evidence required for the issue of a PCN**

- Evidence must show that the driver of the vehicle could see the road markings and failed to comply

#### **Method of Gathering Evidence:**

- In all cases, whether for signs or markings, it will be a prerequisite of evidence, that a record has been made that day, or at the time of contravention, that the sign or markings were present, correctly orientated and in good condition.
- a) A record must be maintained of the vehicle **approaching** in the direction of the box junction, **proceed** into the box junction illegally and **STOP**. A suggested period of 5 seconds is sufficient to prove the vehicle was **STATIONARY** and its exit route was **NOT CLEAR**.
- b) 50% of the vehicle's total length should be shown to be in the Box Junction. However each case should be evaluated accordingly, taking account of the contravening vehicle's total length.
- c) The CCTV operator should follow the vehicle capturing the offence or contravention, Vehicle Registration Mark, Make and Model and, if practicable, signage. The vehicle must then be shown to fail to comply and continue on its route.
- d) A contemporaneous record of the Camera No, Location, Time, Date, Vehicle Description, Signage (Box Junction, Banned Turn etc.) must be kept by the EO and made available on request to authorised personnel.
