- 2. Please break this total down by (a) The total number issued to people in the street and (b) The total number issued to people in custody.***

I can confirm that information relevant to your request is **held** by the Norfolk Constabulary.

To locate the information relevant to your request, searches were conducted within the Criminal Justice Services Department of the Norfolk Constabulary.
