Dear Miss Stewart

The application that was received by the council on 10 February 2009 has now been considered and this letter is a full response to your request about crime rates or statistics for the area around the existing site at Chelson Meadow, both before and after the site was built.

I have now had time to fully consider your application and liaise with relevant officers within the council and colleagues in the police force.

The council does not hold the information that you have requested in that the council does not hold any recorded information about anti-social behaviour or crime statistics for The Ride or surrounding area.

The council does not provide information that is accessible by other means, which is Section 21 of the Freedom of Information Act.

General Information about crime statistics is available on the Devon and Cornwall Constabularies website [www.devon-cornwall.police.uk](http://www.devon-cornwall.police.uk). I am reliably informed that these are not likely to be broken down in a way that will answer your enquiry. This is for several reasons, namely:-

- The geographical area is very small
- Data protection rules would preclude disclosure of any information that could identify individuals
- The area around the Ride is a public right of way and crime data can not be attributed to the Gypsy and Traveller residents just because they live there
- Figures relating to incidents before the Ride was built and until now, would not be comparable like for like for a range of reasons (e.g. re-categorisation of crime types) and so would at best be highly misleading and at worst open to misinterpretation.
