Re: Your request for an internal review of our lack of response to your original request, our reference: IGO/11-8118

Thank you for your email dated 21st March 2011. As the information you requested is not personal or environmental it has been processed in accordance with the Freedom of Information Act 2000.

I have now had the opportunity to investigate your request reproduced below for ease of reference and my observations are as follows:

"I would like to know how much the Council has spent outsourcing to either Barristers Chambers or Solicitors at Employment Tribunals for all Council Staff (including Teaching Staff). Any combination of those below, between 1st August 2000 and the 31 October 2010:

- 1) For constructive dismissal
- 2) Unfair dismissal
- 3) One (or more) of the various discrimination claims and/or under the Protection from Harassment Act
- 4) Public Interest Disclosure Act 1998
- 5) Any other Employment issues, I may have omitted.

Please name the Solicitors/Barristers that the Council have outsourced to: For example, 2010 Number Name. I would request that you include VAT in the figures Please provide the figures in the following format e.g. 2006 – NUMBER HERE; 2007 – NUMBER HERE; 2008 – NUMBER HERE; 2010 – NUMBER HERE; etc, thus making it easier for one to read and to ensure there is no misunderstandings".

The information detailed below is based on information held within the Legal Services section and the figures are inclusive of VAT.

As your request to the Council was slightly ambiguous, in that we were unclear whether, when you said "...all Council Staff...", you are referring to claims brought by
