Review of Freedom of Information Request Numbers 456, 459, 474 and 480

I have now had the opportunity to submit your review requests regarding the above mentioned Freedom of Information Requests to the Core Management Team (CMT).

CMT were of the view that more financial information could have been provided to you for the years 2006/07, 2007/08 and 2008/09 in respect of request number 456 and this is now attached.

With regard to request number 459, further additional information is also attached hereto.

You have made various references to 'late information' and CMT found this not to be the case. The relevant legislation states that the 20 working days commences the first working day after receipt of a request. I would also clarify that if an email request arrives after 5.00pm it will not be deemed to be received until the next day.

I now believe that all outstanding issues have been dealt with. As previously stated, if you remain dissatisfied please refer your concerns directly to the Information Commissioner, details as follows:




