- **Information partially disclosed** - this applies where some, but not all, of the information has been withheld. Even if only a single word is withheld, we would consider the RFI outcome to be 'Information partially disclosed'
- **Closed: no further information provided** - for example, when the requester does not provide sufficient information to make the RFI valid as a section 8 request, or when the requester withdraws their RFI.
- **Information available elsewhere** – this applies for example, when the information is available in the annual report or on the BBC website.
