Thank you for your response to Ofcom consultation on the use of Content Management on the HD Freeview platform. You stated in your response that:

"1.2 The BBC accepts that it would be helpful to Ofcom to have access to the details of the content which the BBC (and other broadcasters) may be unable to broadcast on the Freeview HD platform in the absence of content management. For its part, the BBC is therefore prepared to supply to Ofcom details of the content which has been supplied to the BBC under broadcast rights agreements which would preclude the broadcast of this content in a HD format on any distribution platform which does not implement content management."

It is important that we review all the available evidence before coming to a decision on this matter. We therefore request that you provide details of the content that the BBC would not be able to show in HD on DTT without content management in place.

As part of our analysis we are also reviewing the use of copy management on other digital platforms. Our research indicates the BBC currently applies "managed copy" (i.e. copy once) to all content shown via the BBC/ITV freesat platform. Please can
