

Further to my letter to you on 10 August 2012, I am now writing to provide you with copies of the two discussion documents which have been produced by the Steering Group of the South West Pay, Terms and conditions Consortium (SWC).

The trusts involved in the SWC have decided that they wish to undertake a comprehensive discussion around the themes in these two documents in an open and transparent way. Each trust will be providing an internal briefing to staff, staff side representatives, FT governors (where appropriate) and trust board members immediately prior to the publication of these two discussion documents (at noon on 22 August). The SWC is also issuing a press release and an updated set of FAQs at the same time. All of the documentation will be available on the SWC website (www.meetingthechallenge.info).

I would like to emphasise that these two discussion documents do not contain any decisions and have been produced to encourage informed debate and discussion. One have been designed to set out what the service, financial and economic challenges are over the next few years – so that we can assess whether this adequately quantifies what the twenty Trusts feel could be the case. The other sets out an assessment of the current position relating to pay, terms and conditions given the pay reforms of the past decade, and produces a long list of options for consideration – nothing has been excluded at this stage of the debate as no proposals or decisions have been made.

Finally I would like to thank you for your reply to my previous letter, where you have indicated that your trade union is prepared to meet Chief Executives of the SWC to examine the challenges which face the NHS. I will share your response with colleagues and we can discuss how best to make this happen practically.

I look forward to hearing from you.

Re: South West Pay, Terms and Conditions Consortium

I am writing to you, as Chair of the trust's staff-side representative body following a letter I have sent to all regional trades union officers in my capacity as the Chairman of the South West Pay, Terms and Conditions Consortium (SWC) seeking engagement at regional level of the South West Social Partnership Forum in the work of the consortium.

I would like to extend an open offer to engage with you and your staff-side colleagues as part of our efforts to meet the service, economic, and financial challenges facing the NHS in the South West over the next three and subsequent years.

Our task is to evaluate the challenges in providing patient service over the coming years – and consider whether changes to pay, terms and conditions could make a contribution to making NHS organisations viable and able to provide high quality and accessible patient services.

I recognise the trade union's position with regard to maintaining pay, terms and conditions – and that this is a very difficult issue. The NHS employers involved in the SWC have not taken the decision to explore this area lightly.

I would like to engage with you on the basis that we value your opinions and want to hear the views of staff on the potential options facing every NHS employer within the South West.

The SWC plans to publish **discussion documents** later this month in an open and transparent way, which I will send to you on the day of publication, and look forward to discussing these with you.

In summary, I emphasise that the SWC is totally committed to working with the trades unions and staff, especially at a local employer level. We are open to how this engagement can take place – and I would welcome a discussion about how best to make this happen. I should underline that the SWC has not taken any decisions with regard to pay, terms and conditions and is not launching consultation, rather a period of engagement.

Please do let me know what you think – I would be happy to discuss with you what you think could be possible with regard to engagement.

I look forward to hearing from you.
