Dear Mr Dean,

Thank you for your email of 13 December 2017 in which you requested:

“Please provide a complete list with licence numbers of all PEDLs that the OGA has 'moved' from their second term into their third term since the 1 April 2015, together with the effective date of when the third term commenced.”

We have considered your request under the Freedom of Information Act 2000 (**FOIA**) and, where relevant, the Environmental Information Regulations 2004 (**EIRs**).

The licences which have moved into the third term since 1 April 2015 and the effective date of the moves are:

- PEDL145: Doe Green FDPⁱⁱⁱ approved, moved into Third Term 30/09/2016 (later conversion to MC and RA)
- PEDL146: Date into Third Term 30/09/2016 by conversion to MC and RA
- PEDL147: Date into Third Term 30/09/2016 by conversion to MC and RA
- PEDL148: Date into Third Term 30/09/2016 by conversion to MC and RA
- PEDL149: Date into Third Term 30/09/2016 by conversion to MC and RA
- PEDL157: Date into Third Term 30/09/2016 by conversion to MC and RA
- PEDL158: Date into Third Term 30/09/2016 by conversion to MC and RA
