## **REQUEST UNDER THE FREEDOM OF INFORMATION (SCOTLAND) ACT 2002 (“The Act”)**

Thank you for your request for information dated 21<sup>st</sup> December 2021 where you asked for the following information:

**“I'd like to request some information on the number of attempted thefts the Culture and Sport museum has had over the past 10 years.**

**Can you please provide me with a list of the number of attempted thefts for each year since 2011.”**

Culture & Sport Glasgow (trading as Glasgow Life) is treating your request as a request for information under the Freedom of Information (Scotland) Act 2002. We can confirm that Glasgow Life holds the information that you have requested and can respond as follows:

Between January 2011 and December 2021, we can advise that there have been four attempted thefts within Glasgow Museums.

### **Right of Review**

If you are dissatisfied with the way Glasgow Life has dealt with your request you are entitled to require Glasgow Life to review its decision. Please note that for a review to take place you must:

- Lodge a written requirement for a review within 40 working days of the date of this letter

You must request an internal review by Glasgow Life before a complaint can be directed to the Scottish Information Commissioner.
