**As you know, on the 1st of July we established the NHS Greater Manchester (NHS GM) Integrated Care Board. The Board has a wide membership, and this includes Dr Manisha Kumar as Chief Medical Officer and Dr Vish Mehra as the Partner Member bringing the perspective of Primary Care. Partner Members of the Board bring perspectives from their sector but the Board as a whole is responsible for decision making about GM health and care services.
