I wish to object to the above proposed development on the following grounds

1. Proximity to residential housing and schools, I feel it is inappropriate to locate the facility so close to a large, and expanding residential area. This is especially apposite given the fact that air quality in the Stanwix area is already failing to meet required standards on many occasions.
2. Proximity to Nature reserves and SSSI. I am especially concerned with potential problems with uncontrolled run off due to severe weather incidents, and potential build up in the ecosystem of harmful chemicals, and heavy metals. Similarly airborne pollutants especially nitrogen are known to have a negative effect altering ecosystems, particularly oak woodlands.
3. The effect of increased road, will adversely impact road safety, road congestion, nuisance with round the clock heavy traffic, road pollution and carbon footprint.
4. Visual impact, the new building and chimney is disproportionate in scale to other developments, and will dominate the local skyline. With Carlisle city council attempting to promote the city as a tourist destination this will not be an asset to the community.

I wish to lodge an objection to the above planning application for the following reasons

Its position in respect of Government Planning Policy.

My most important point of objection is that WRAP EfW guidelines indicate that these facilities should not be located near residential areas, school or local nature reserves. This development is close to all three of those categories.

300-400m to the Kingmoor Nature Reserve
730m from the nearest residential accommodation
1000m approx from a school

Design out of keeping with the character of the area.

Most buildings in and around Kingstown Industrial Estate are low rise warehouses, workshops etc up to 3 storeys
This development is much higher, especially with the chimney, and is not in keeping with the other buildings already in place

Dominant and oppressive environment created by the proposal.

The proposed development is adjacent to a local nature reserve and close to a residential area with a junior and primary school.

Excessive noise, dust, smell or nuisance.

100 HGVs are expected to arrive on site daily. There are several objections to this

- Carlisle cannot produce 100 lorry loads of non-recyclable refuse per day. The lorries would therefore have to come from out of area resulting in additional, longer journeys which in turn would have an impact on the environment.
- Noise pollution would increase – reversing beeps 24 hours per day
- Noise pollution particularly at night from the generator
- A similar plant at Dumfries has frequent shutdowns for maintenance or breakdown. Whilst inoperative there will be a build up of smelly waste waiting to be incinerated and that this will increase flies and rodents in the area. This, combined with the existing problems of the smell that occur from the abattoir will make the situation unbearable

Impact upon Conservation areas.

Being so close to Kingmoor Nature reserve there is a detrimental effect for those who currently use the area through increased traffic and loss of amenity due to the sheer size of the development

Visual or Landscape Impact

Other buildings on Kingstown Estate are not visible from Lowry Hill being screened by the trees in the nature reserve and the bank behind the bungalows on Lowry Hill Road.

The recent Residents Association newsletter shows a mock up (below) of the development from Lowry Hill Road which has a hugely detrimental effect on the visual landscape. I live almost opposite the red car in the photograph

The existing bank and trees which screen the houses from the industrial estate are shown behind the bungalows on the right



There have been ongoing issues with the abattoir regarding smells which the authorities have been unable to resolve. There are still smells from time to time, and as this is only a small enterprise which is still creating smells I doubt that the authorities would have any effect on this much larger operation should problems arise

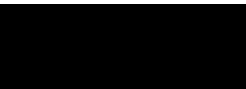

In view of the Carlisle City Council Planning Department Website being shut down for either maintenance and/ or over use, I am writing this email to register an objection to the referenced proposal for the construction and operation of a Waste for Energy Plant on the following grounds:

1. The proposed facility is planned to be situated in close proximity to Kingmoor Nature Reserve and a residential area with two schools, primary and junior schools. The plant is similar in nature to the waste for energy plant built at Dumfries which was been closed down for repeated breaches of “safe” emission levels of cancer causing dioxins. I do not believe that there is such a thing as a “safe” level of emissions of cancer causing dioxins, especially given the close proximity of children, schools and residences.
2. The proposal does not appear to show sufficient concern for the the overall effect on the surrounding residential and light industrial areas, of huge emissions of smoke, noxious fumes, noise and light pollutions caused not only by the running of the plant but also the massive increase in heavy vehicle traffic that would be produced with 100 trucks a day of waste being driven in and out of the plant.
3. It appears that the levels of pollution proposed by the operation of this plant would be less than the levels already emitted by Kingmoor Road and this is given as a positive in the application. I contend that not only is this a negative aspect but it is a doubly negative aspect as the implication is that the plant would have the effect of reducing the pollution to levels below Kingmoor when, in fact, any pollution produced would be in addition to the Kingmoor pollution levels.
4. My understanding is that the proposed plant is to be sited opposite Thomas Graham Steel premises on the new bypass. Although this is an industrial site it is classed as a light industrial site and is therefore totally unsuitable for such a huge heavy chemical plant of this type. Additionally this huge processing plant would be the first sight visitors using the bypass would have of Carlisle and would give a totally false impression of the city as being an industrial wasteland instead of the historical and cultural city that it really is.
5. The bypass was originally intended to facilitate the movement of traffic from the motorways to the West of the County and also to reduce the traffic entering the City by way of routes from J43 and J42 of the M6 Motorway. Any benefits that may have accrued from the (very expensive) construction of this bypass would be negated by convoys of potentially dozens of trucks of foul smelling waste queuing to enter the plant.
6. The type of technology to be utilized at this plant is, I believe, untested in the UK, although similar to that used at the plant in Dumfries. This has resulted in frequent shutdowns for

maintenance and breakdowns in the Dumfries plant and also excessive levels of emissions of cancer inducing dioxins and there is no reason to think that this plant will be any more efficient. In which case there will be an inevitable backlog of noxious waste waiting to be incinerated leading to an increase of flies and rodents in the area, which could give rise to potential outbreaks of diseases.

The volume of HGV deliveries each day will create pollution and disruption, and considerable noise pollution particularly through the night.

The planned structures are very large, and I do not believe they are appropriate for the area. Although the area is an industrial estate these buildings would be on much larger scale to the majority of buildings on the estate, and not be in keeping with the surrounding industry. The visual impact on local housing areas, and the nearby Kingmoor Nature Reserve, should not be overlooked.

I am concerned as to whether this plant will really be an environmentally friendly as suggested. There is concern that the emissions will not be as low as suggested, and this will have an effect on nearby housings areas, including where I live, and business areas, where I work. It may also be detrimental to the Kingmoor Nature Reserve conservation area, which is very close to the proposed plant, and is a major asset to the area and the city, used by many people for recreation.

I do not believe that a waste energy plant, such as that planned, should be situated so close to large housing estates. There is too much at stake to risk allowing this plant to go ahead.

Design and Character

Following the recent public consultation where I made my views known via email there followed a design change to the original displayed version. The new 'design' now indicates lower eaves and curved roof with graduated coloured panels. This I believe is progress but not sufficient. The current proposal whilst situated in an Industrial park is on the main bypass for Carlisle and therefore seen by all who pass by. As stated previously we the public should not be subjected to such a large scale/mass building the height of the Civic Centre and thereby completely out of context with the surrounding sheds. More effort should and could be made to disguise the height and function of this building. There are numerous examples of this facility around the country which comprise of curved roofs, grassed roofs, glazed visitor/information centres all giving character and form to an otherwise functional shed, some have even been award winning.

We should not be subject to a cheaply constructed building that has no form and once the debris and pollution of the general surroundings begin to take effect after a few years will render the building to exactly what it is, a refuse centre.

I note in the submitted environmental document that one of the comments regarding its size and visibility from Lowry Hill estate is that it will block out the light polluting eyesore of the Lighting structures to the railway. This however I do not deem to be a valid reason for gaining approval. The fact that the chimney and building can be seen from a far reaching distance as evident in the reports appendix maps and deemed insignificant again is not a valid reason to add yet another tall featureless shed to the horizon.

I assume [REDACTED] of Duddon valley South Lakes and owner of Kingmoor Park would not be too happy to have the facility in his line of vision and therefore I do not wish to have it mine unless the architecture is vastly improved.

I wish to record my objections to the above Planning Application for the following reasons.

1. INADEQUATE CONSULTATION

- The developer has claimed to deliver community consultation documents but only within 1km of the proposed site. This conveniently excludes the majority of the housing estate which will be primarily affected, myself being within 1300 meters of the site.
- The On-line Environment & Planning website to submit representations comments seems to have technical difficulties stopping residents from recording their objections on-line (<https://cloud2.atriumsoft.com/ePlanningCMB/loadRepresentation.do?pprApId=44371>)

2. RISK TO PUBLIC HEALTH DUE TO PROXIMITY OF SCHOOLS AND HOUSING ESTATE

- There is an absence of information from the developer regarding the amount of heavy metals or particulate matter that will be emitted from the incinerator. Despite what the developer may claim the incinerator represents a significant risk to public health. This argument is supported by the following legal and textual evidence.
- There is also an absence of any detailed assessment of the wind flow patterns and local atmospheric conditions that would exacerbate the risks of air pollution for schools and local inhabitants.
- Article 2 of the Human Rights Act requires government bodies to take reasonable steps to protect susceptible inhabitants from the effects of air pollution if they are aware, or should be, that it poses a real and immediate risk to their lives. There is now ample evidence that air pollution does pose a risk to life – in fact it causes around 9,500 early deaths in London per year. We also know that the air in many parts of London, as well as cities beyond, is so dirty that we have been in breach of EU air quality limits since 2010.” (<https://www.theguardian.com/society/2016/jun/05/mother-inquiry-air-pollution-daughter-asthma-death>)

- 12 May 2016 - Carlisle was cited by the World Health Organisation (WHO) as one of the 40 cities areas across Britain & Ireland that breached the safe limit set for PM2.5, the smallest, most harmful pollution particles. "These particles are able to reach deep into our lungs and even into our bloodstream, and can have a serious impact on our breathing and wider health." (<http://www.mirror.co.uk/news/uk-news/towns-cities-breaching-air-pollution-7950938>)
- 09 Dec 2015 - The European NGO, which has the UK Without Incineration Network (UKWIN) among its supporters, says that air pollutants which EfW practices can emit, such as dioxins, heavy metals and particulate matter "cause well-known respiratory diseases, cancer, immune system damage and reproductive and developmental problems". (<http://www.airqualitynews.com/2015/12/09/air-pollution-waste-incineration-significant-report-warns/>)
- The prevalence of COPD in Cumbria 1.9% is higher than national average of 1.5%. In 2009 the North West recorded 2,409 compared to London 1,778.
- Cumbria County Council are opening themselves up to prosecution following the successful case against the government on air pollution ClientEarth v Defra April 2015 and the impending case of Rosamund Kissi-Debrah v Greater London Authority. These cases are fully supported by the Royal College of Physicians – Every breath we take; the lifelong impact of air pollution published 23 Feb 2016.

3. KINGMOOR NATURE RESERVE

- The reserve is recorded by the Carlisle County Council as a bird sanctuary and an agricultural reserve. It serves to protect wild life, both plant and animal dating back to March 1914.
- The developer has not taken in to account the effect of pollutants from the incinerator on Kingmoor Nature Reserve, merely dismissing that there will be none.
- Dioxins, furans can enter the food chain representing hazards to humans as detailed in the following journal (<https://www.degruyter.com/downloadpdf/j/bvip.2015.59.issue-4/bvip-2015-0078/bvip-2015-0078.xml>)

4. THE PROPOSED DEVELOPMENT DOES NOT HAVE THE BACKING OF THE AFFECTED LOCAL COMMUNITY

- The Lowry Hill Residents Association has gathered physical and electronic signatures to show that the significant majority of residents on the estate are not supportive of the development of the incinerator so close to a housing estate and two schools.

5. SIGNIFICANT VISUAL INTRUSION OVER A WIDE AREA

- The photographic views of the proposed incinerator from Lowry Hill road is taken in such a way as to mislead people as to the real impact of the building. No scale or elevation information is available to support the image, the height of the cooling tower at 70 metres is shown to be the same height as the nearest lamppost.
- The proposed site will create an eye sore for visitors to Carlisle to see the remnants of Hadrian's Way or those making their way on the National Cycling Route. Should the incinerator create foul smells as experienced in Dumfries, then this will affect tourism.

6. TRANSPORT STATEMENT

- There is an increased risk of accidents to locals traveling by car in the area due to the high volume of lorries visiting the proposed site each hour. This number will increase if the proposal is accepted. This is compounded by the unknown number of Lorries carrying chemicals to and contaminated waste away from the site.
- This additional traffic will only add to pollution for the local inhabitants.

In light of the above, I believe that this applications should be refused.

Dear Sir,

My wife and I wish to object in the strongest possible terms to the above proposal. At the outset, we wish to say that we endorse the views outlined in the objection already submitted by Lowry Hill Residents Association. Those views are not driven by a "Nimby" outlook on development, but by genuine and well-founded fears for the health and environmental impacts of this proposed facility.

Firstly, it is a long-held principle of planning law that proposed developments should be appropriate in scale and character for the site in question. This facility is patently not appropriate. It would be so huge that it would dwarf everything near to it, and intrude into the views of residents in a large part of Lowry Hill, where we have lived for the last 20 years. Such buildings - enormous by any standard - are not appropriate on the edge of residential areas. Nor would it be appropriate within a short distance of Kingmoor Nature Reserve, which is an asset to be cherished and protected. I urge your committee to look at this area of woodland on Google Maps, using the satellite view. You will see clearly that it and Lowry Hill are a rare oasis of greenery in our rapidly expanding city. Why spoil it, allowing the industrial estate to our north to intrude into such a green area? Having seen the images provided of the proposed facility, there is in our mind only one word that adequately describes it: oppressive. Councillors should ask themselves: would I want that on my doorstep?

Secondly, it is clear that the basis of this technology is not low-carbon. In an age where most informed decision-makers are striving to adopt energy technologies that do not fuel climate change, why take this retrograde step? For the sake of our children, and their children, Carlisle needs to be a leader in rejecting carbon-emitting energy sources. There is also the powerful point - raised by LRA - that such a technology could encourage the creation of burnable waste. It could also lead to Carlisle becoming known as the North's "Waste City." Hardly a reputation to pull in the tourists. My wife and I appreciate that jobs are desperately needed in this area. But the bulk of the employment created by this project would be temporary. That is not a price worth paying for scarring this community with an ugly, polluting building for decades to come.

Finally, we wish to raise what is perhaps the biggest personal concern - the unanswered questions about the potential health effects of this proposed project. Lowry Hill is an estate with two larger than average primary schools; and with around 1,000 homes, most of them with children living in them. It's a place where the green space of Kingmoor Nature Reserve encourages outdoor activity, walking, and a love of nature. Nothing we have read about this proposal has shown us that this technology is proven to be safe. Our instinct is that it is not. It may well be potentially hazardous. Incinerating waste will generate vast quantities of airborne toxins. Such a facility should be near a residential area. The proposed chimney - probably the second highest structure in the Carlisle if built - will give no guarantee that these emissions will not be inhaled by the men, women and children of Carlisle, exposing them to goodness knows

consequences. It is not a risk worth taking. It is certainly not a risk that any sane person would take. So we implore you, do not allow this ill-advised project to go ahead.

Planning Objection

Application Number: PL\1572\05 (1/16/9005)

Dear Sirs

I wish to object to the plans for the Energy Recovery Facility at Kingmoor industrial Estate. I have several issues upon which I am not satisfied, and have detailed them below. I would appreciate confirmation of receipt of this email.

a) Design out of keeping with the character of the area

Carlisle remains an open city, with very few tall buildings. The local hospital, the civic centre, Debenhams are the only modern structures of any significant height that are less than 100 years old. The plans to build a large building (approx. 40 metres) with a 70 metre chimney on the north of the city are massively out of character for a city whose primary attractions and future prosperity may depend on its ability to balance the types of economic development against its status as an historical city with great tourism and activity based growth potential.

Whilst zoned for industry the building and its use would also be significantly out of character for the types of business on the industrial estate. These are predominantly transportation, distribution, light metal fabrication, and offices. This industrial area also borders residential areas, and a retail area. The character of the building impacts negatively on the character of the area in all these regards.

b) Dominant and oppressive environment created by the proposal

For many people the idea of such a plant is oppressive in itself, I do not share this view and believe that such a plant in the right location can be a benefit for the county.

It is important to recognise that the stigma caused could cause Carlisle to develop the reputation as a waste city. Taking rubbish from all over the county and further afield will have a direct impact on the attractiveness of the city as a place to do business, particularly tourism and activity based businesses which are a rapidly growing sector of the economy. Food business which represent an important part of Carlisle's economy are also affected by this kind of development, as seen in the reasons for rejecting an Energy From Waste facility in Carmarthenshire recently.

The choice to build this facility at a high point of the city, visible from all the nearby housing and visible from miles around means that the presence of the building, the associated stigma of its activity impose on the environment of both the local homes and schools, businesses and the city as a whole. It will do so in such a way as that it can only be characterised as dominant and oppressive, especially when you consider that it will be visible for miles around in all directions and that's from research I have conducted on plants in America that the smoke plume could be visible from as much as 20 miles away.

c) Visual or Landscape Impact

As a building it is utilitarian and unattractive, a similar facility using different technology in Leeds has spent significant amounts of money ensuring that the site blends into the skyline using various architectural and design features including a living wall, bunds, creative architecture and materials; and maximising distance from residences.

Due to the site choice, the ability to minimise on these aspects is limited, and I am convinced there are many better sites across the county. Comparing developers photo's with current sight lines, it is evident that many of the best views from and across the north of the city will be impinged or blocked by the building; particularly those of the hills and mountains to the north of Carlisle

d) Excessive noise, dust, smell or nuisance

Based on the operation of other waste management facilities of Cumbria and Dumfriesshire (Barrow bio-digester, the Dumfries waste incinerator etc), I have no faith in the ability of this operator to manage waste any better than other operators. No matter how clever or apparently sufficient their operation seems to be, it is an unacceptable risk for the 100000 people living on the East of this facility to take a risk on the skills, and probity of the developers. It is entirely reasonable for planning decision makers to take this into consideration. It only takes on bad mistake for the city to be swathed in dioxins which can cause cancer and birth defects.

e) Impact upon Conservation Areas or mature trees

Building this facility within a few hundred metres of Kingmoor Nature Reserve is inappropriate. This is England's oldest nature reserve and is deserving of the highest protection not just of its physical assets such as trees and wildlife, but also that the maximum amenity level should be retained. For those with limited mobility and the elderly, this beautiful woodland area represent a real escape into the wilderness on their doorstep. With the huge chimney planned, it will be visible form a large number of places in the wood, where no development is visible at present. Please protect our right to enjoy the privacy and peace of Kingmoor Nature Reserve.

Final thoughts.

Regardless of the merits of the technology, I believe that with two schools close to the plants proposed site and with over 1000 new houses and therefore new schools likely in an arc around the plant, that councillors and planners would want to take zero chance on the health and well-being of families and children. It only takes one catastrophic accident for this plant to be a disaster for the whole city.

I am a registered nurse with specialist training in respiratory disease. A resident of Lowry Hill for over 20 years and recycling for as long. I am sympathetic to issues associated with recycling. I agree with the objections raised by the Lowry Hill Resident's Association against a planning application by Stephenson Holiday Limited to Cumbria County Council for an Energy Recovery Facility at Kingmoor Park Industrial Estate. The Application number is as above. I believe these objections are valid and I cannot see any benefit to local residents in having the proposed Recycling Plant on our doorstep. My main area of concern is the potential Health problems it may bring especially to children here and the nearby two schools. Negative Health Issues would be difficult to dispute with accuracy but I do have experience of local children with Mental Health Issues due to a stench from the local abattoir causing them anxiety and lack of Well-being. I do not have any young children or grandchildren here but I believe in the saying "It takes a village to raise a child" and that we have a responsibility for the Health and Well-being of the vulnerable living amongst us. Other personal experiences are of a "rat invasion" to a neighbour's outbuilding and to some penetration by rats to properties on Scotland Road. This all occurred when Lowry Gardens was being built. My wife and I would like to object to the proposed building of an energy recovery plant on the Northern Bypass Carlisle.

Having looked at the plans and researched what the facility is about, we would like to object on the following grounds

Traffic

We believe that there will be severe traffic disruption whilst this is being built and after when in use. This is already an extremely busy part of Carlisle, and frankly further volume of traffic would cause further delays, pose safety risk and make it even less an attractive place to navigate around.

Environment

We do not think the site is suitable, being so close to the town and major residential areas. This project would be far better situated far away from residents, schools and a wildlife reserve. We are worried about the effect this may have on our general air quality, whilst the chimney is over 70 metres tall, the exhausts will be seen for a very far distance, and wafting directly over us, the school, the nature reserve and through the pollution already caused by traffic pollution in a busy area.

Landscape

The chimney will be an eye sore to many if not all the residents of Lowry Hill. This is in keeping with how our landscape looks now, nor in any way a landscape anyone would want to see in the future. It will dominate the skyline, and the smoke waste will be visible, making for a very unattractive view, with a daily reminder of worry as to the safety of local residents (air pollution and the threat of fire, other damage or terrorist attack)

Finally, we are concerned about the impact this will have on wildlife, not just in the wildlife part, but on the farming areas around the plant.

As council tax payers in Carlisle for over 20 years, we feel that this project has no place in the area where it is proposed, it needs to be away from houses, schools, shops and wildlife park. Please take this as an objection to the scheme and factor this when making your decision

It has proved difficult to do anything about this problem within a reasonable timeframe. WRAP EFW guidelines indicate that these facilities should not be located near residential areas, school or local nature reserves. We write as advised to register our comments regarding planning permission application ref. no. 1/16/9005, the erection of an energy from waste plant on land to the north of King's Drive, Kingmoor Park, Carlisle.

We ourselves are long-standing tenants of Kingmoor Park Properties, currently occupying Unit E2 on Kingmoor Park Central, the building immediately adjacent to the site of the proposed development. Our business is the baking of high quality Crumpets and we serve a host of customers of all sizes, from the big 4 UK Retailers down to small independent bakeries, we also supply the foodservice sector and export to Europe, the Middle East and the US.

We established our business in late 2005 and enjoyed consistent growth up until May 2015 when we suffered a devastating fire at our then neighbouring premises in Unit J. The loss of our baking equipment was total and the building was damaged beyond economic repair.

For the last year with the help of our insurers and our landlords, Kingmoor Park Properties we have been fully engaged in rebuilding our business and recreating the 25 jobs that were lost. We were immensely proud to recommence trading from our new purpose built bakery on 1st May this year.

We have invested over £2.2M and have recreated 10 jobs to date. Many of our former customers have happily returned to us, and we are currently engaged in re-securing listings with major UK retailers. Over the coming months we hope to recreate a further 15 to 20 jobs, returning our headcount back to pre-fire levels. As we now occupy much larger premises than we did previously, we also now have room for further expansion and would hope to create a significant number of additional jobs over the next few years.

We were somewhat surprised to learn of the proposed development of a waste treatment plant adjacent to our bakery in late April. I am sure you will appreciate our concerns that this development being in such close proximity to our food factory has only negative connotations for us.

We do not wish to stand in the way of progress and job creation, however must register our objection to this proposal on the grounds that it will adversely affect our business, whether these effects are perceived or factual is largely irrelevant, a bakery next door to a waste processing plant is not a happy association.

A key component of our manufacturing process is a clean fresh air supply to our bakery. Last May when deciding to make the investment we have, we would certainly have rebuilt elsewhere if we had known this proposal was under consideration.

I am writing to express my objection to the plans for the Energy from Waste (EfW) Plant planned for Kingmoor Park Industrial estate.

Having attended a local residents association meeting with the company proposing to build the facility it was blatantly obvious that, regardless of the rights or wrongs of EfW plants, this one is planned for completely the wrong location. Although I am not a resident living so close to the proposed plant (I live in Stanwix, just off Scotland Road) I am objecting as I do not feel other residents in Carlisle should have a plant such as this so close to their homes, nor school children be at school near such a plant.

With regard to the planning considerations I would like to object to it on the following grounds:

1. Design out of keeping with the character of the area

We have very few tall buildings in Carlisle, which from a tourism point of view (a key aspect to our economy) gives the city a much more pleasant aspect. As I understand it the main building is almost the height of the Civic Centre and it has a 70m chimney. As such the main building is going to have a major visual impact. Although it is sited in an “industrial area”, as I understand it the surrounding buildings are mainly warehouses, showrooms and office accommodation, not other major industrial processes such as this plant. This industrial plant would be completely out of character with those. Furthermore it is in very close proximity to Kingmoor nature reserve, Kingmoor nursery, infant and primary schools and a residential area. I also note that the Waste Resources Action Programme (WRAP) EfW Development Guidance recommends that EfW facilities should not be located within close proximity to residential areas, local schools or local nature reserves. WRAP provide information on best practice in waste management and recycling services to Local Authorities, amongst other organisations.

2. Dominant and oppressive environment created by the proposal

Considering the aforementioned size of the plant, and that it is situated at a high point in the city, it will have a significant and dominant visual impact for all those working in the industrial estate, for residents in parts of Lowry Hill and from locations in and around Kingmoor Nature reserve. That this plant will, despite reassurances from the developers, be emitting pollutants into the local environment, contributes to its oppressive nature, particularly for local businesses, local residents and visitors to the nature reserves.

3. Excessive noise, dust, smell or nuisance

Considering that this plant will be running 24 hours per day and lorries will be bringing deliveries of waste across the 24 hour period the noise both from them and also the running of the plant is likely to cause disturbance to residents, particularly at night time. The National Planning Policy for Waste (NPPW) appendix B states the considerations waste planning authorities should consider. In its locational criteria it includes: “The operation of large waste management plants in particular can produce noise affecting both the inside and outside of buildings, including noise and vibration from

goods vehicle traffic movements to and from a site. Intermittent and sustained operating noise may be a problem if not properly managed particularly if night time working is involved.”

I would also have concerns regarding smell and nuisance from the waste. If the plant has to shut down for whatever reason what will happen to the waste that is being brought for processing? If this is left for any length of time, particularly in warm weather I could see this causing considerable local smell and nuisance, for example flies and vermin, for local residents.

Wider than this I also have major concerns about the waste products from the plant. The very process of the plant converts products that are harmless into by-products toxic to the environment and human health. Although the developers gave reassurances that products such as very toxic dioxins, heavy metals and others are prevented from entering the atmosphere, they are still produced in the gasification process, will remain in the waste product from the building and as such are therefore at risk of getting into the environment leading to documented negative health consequences. Once into the food chain the effect of dioxins accumulate to give more toxic impacts on human health. There will also be a large carbon footprint from the plant, not only in its emissions, but also in the emissions from its manufacture and the vehicle movements to and from it. An argument was given by the developers that it is better than putting waste in landfill from an emissions point of view but, following discussions with a waste management professional, I understand that the methane produced by landfill can be taken off and used so that it does not add to greenhouse gasses, and so does not provide an argument in favour of the EfW plant.

4. Impact on conservation areas and impact on local wildlife and biodiversity

The planned plant is situated only a few hundred metres from Kingmoor Nature Reserve. This is a special and accessible place for our community where many come, who maybe cannot travel further afield, to get closer to nature and the countryside. The visual intrusion of the plant will be of real detriment to this experience. I would also be concerned if any incident of environmental contamination from the plant impacted upon the flora, fauna and wildlife in the nature reserve, not to mention local residents.

5. Visual or Landscape Impact

The image shown on the picture of the plant as seen from Lowry Hill Road shown at the resident's meeting gave some idea of the size of it. There was an audible intake of breath in the room as people saw it. The plant is going to have a significant visual impact, from parts of Lowry Hill, from parts of the nature reserve, possibly Cargo, Crindledyke, and I would also expect from parts of Carlisle south of the river and Grinsdale looking north towards it.

6. Compliance with the Local Plan (i.e. Local Planning policy)

I note that the Mineral and Waste Local Plan for 2015 to 2030 is still in draft form. I am assuming that supercedes previous plans including the 2012 Site Allocations, Policies and Proposals map and would question therefore the current validity of the latter in terms of locating this plant as it may no longer be valid in relation to more recent national government guidance. Should any decisions on that front not wait until the new plan is approved bearing in mind that plan is for 2015 onwards?

Another couple of points I want to make. The plant will create local jobs – but any sort of other waste management scheme will also create jobs and so I would not see this as an argument for building such a plant.

Finally, although I appreciate that this concern is not necessarily one for the planners, it is a major concern for me. I truly do not believe that EfW plants are the way forward for our waste management or energy production. There is already more than sufficient capacity of these plants in Europe and the UK. Due to the fact they need a constant source of fuel in order to run they

disincentivise reduction and reuse of waste and waste valuable resources by burning them rather than conserving them and reusing them. We should be moving forward to a zero waste system wherein we reduce the overall amount of waste produced, reuse everything possible, recycle where we cannot reuse, compost all organic matter, use anaerobic digesters and phase out any products which cannot be disposed of through this pathway. If our Council wants to truly move to more sustainable waste management this EfW plant is not the way forward. I would be grateful if you would let me know if there is a way in which it is still possible to feed into the Council's waste management plan or other way to influence council decisions on this front. I was completely unaware, until today writing this objection, of the consultations that have been going on both previously and this summer on the Council's Minerals and Waste Local Plan and was therefore unable to contribute.

I wish to object to the plans for the Energy Recovery Facility at Kingmoor industrial Estate.

There are a number of issues which I am not satisfied with, these are:

a) The design is out of character with the other developments and architecture in the area. Carlisle is a small city next to the Scottish border, and some of the revenue is from tourism. The buildings in the city are a mixture of ancient, old and new. There is a balance of buildings, old and modern. New buildings are typified by the new Debenams building and the hospital, which are relatively low in stature. This development on the edge of the city, will be completely out of character with all others in the area. The main building at 40 m high is far taller than any other building in the area, and the chimney at 70 meters will be about the highest structure (from sea level) in the city of Carlisle. It is out of character both in design and function with the building.

b) Dominant and oppressive environment created by the proposal
Many of the people I speak to are against the idea of an incinerator or waste to energy facility at all, some people are scared. This is extreme, and is not the way I feel, after reading about these structures. My concerns are that the size nature and proposed positioning of this development will result in an oppressive overpowering vision, in this light industrial environment, with a nature reserve and several schools close by. Indeed, the area has large shopping and residential areas in close proximity. The building and especially the chimney will be visible for miles, and can only be described as oppressive.

c) Visual or Landscape Impact
The building is unattractive, and looks like it might be somewhere that hundreds of wagons go to, carrying waste - to burn. Visible from residential areas, the Kingmoor nature reserve and passing traffic going to West Cumbria, it will have a poor visual impact and be a blight on the landscape. There are thousands of people living in relatively close proximity, who will see this from their homes, travelling to work and taking their children to school.

d) Excessive noise, dust, smell or nuisance
Based on the operation of other waste management facilities of Cumbria and Dumfriesshire (Barrow bio-digester, the Dumfries waste incinerator etc), I have no faith in the ability of this operator to manage waste any better than other operators. Technology is great, when proven. This is the first development of its type in the UK, and experience of similar new high tech waste to energy projects has shown that initially these should be tried out in less sensitive areas, where fewer people would be affected if the noise and emissions did not meet what was expected. Please protect our right to enjoy the privacy and peace of Kingmoor Nature Reserve, one of the oldest nature reserves in the UK.

With two schools close to the plants proposed site and with over 1000 new houses and therefore new schools likely in an arc around the plant, that councillors and planners would want to take zero chance on the health and well-being of families and children.

Unforeseen problems and accidents have had disastrous consequences for other communities, please do not let this development go ahead in the proposed location.



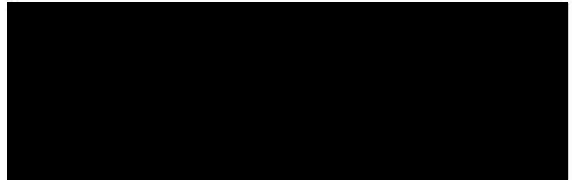

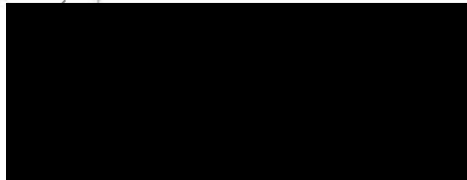

I wish to express my support for this application.

I believe this application should be permitted on environmental grounds. There are so many alternative energy projects that seem to be permitted despite the appalling efficiency that is associated with them. Wind farms that will never generate the power that it takes to produce, erect and maintain them. Conversion of traditional fired power stations to use wood chip pellets that have to be shipped thousands of miles from Canada. Now we have solar farms where the thermal efficiency reduces as the light intensity increases. Yet here, we have a power generation scheme based on proven technology that will prevent land fill, will generate power on the doorstep of the trading estate that will use the power and is situated in an area designated for industrial and commercial business.

I have seen tracts circulated by the opponents to this scheme and I am appalled by the fatuousness of the objections. The proposed site is adjacent to the road that was designed to take heavy traffic through that area, and I cannot envisage the volume of traffic increasing to any alarming degree. It isn't as if an open cast coal mine were being proposed.

Equally, it will be an industrial building on an industrial site, not adversely affecting the visual amenity of the area, unlike wind turbines. From the housing estate, on which I also reside, the wooded area of Kingmoor will screen the development.

In recent years, there have been 2 major incidents of which I am aware, where large stockpiling of materials for recycling have caught fire and the uncontrolled combustion of these materials has created significant problems for local residents. And yet the recycling process continues with the same potential for contamination. Conversely this proposal seeks to burn the collected materials in a controlled manner at extreme temperature to avoid environmental pollution.

I believe this proposal should be permitted and commend this to you.

Despite the fact that the proposed location is in an industrial estate the types of development on the estate are mainly warehousing, showrooms and office accommodation. This would be the first major combustion type of process in the estate and it is adjacent to a local nature reserve and close to a residential area with a junior and primary school.

Dominant and oppressive environment created by the proposal.

This development includes very large structures which will have a huge impact on the outlook from the elevated areas of Lowry Hill Road and some locations around the Kingmoor Nature Reserve.

Excessive noise, dust, smell or nuisance.

The plan is to service this incinerator with 100 HGV deliveries per day. Each of these deliveries will require the reversing of the HGV into the reception hall with accompanying reversing beeps. I am concerned that this will cause significant disturbance and distress especially when this occurs during the night, over weekends and during holiday periods.

We are also concerned that the distance from the nearest residential accommodation (730m) means that the noise of the waste treatment and the generator will cause disturbance especially during the night.

We are concerned that this type of technology (untested in the UK) will inevitably result in frequent shutdowns for maintenance or breakdown. We are concerned that at these times there will be a build up of smelly waste waiting to be incinerated (as occurred at the Dumfries EfW plan) and that this will increase flies and rodents in the area.

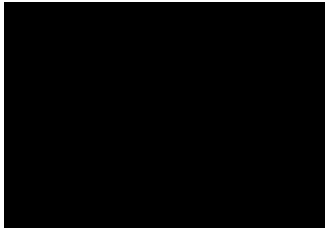

I understand the building itself will be enormous some 40 m in height and the chimney going up to much higher level of 70 m! This will be an eyesore at the very least. 

I am writing to express my objection to the plans for the Energy from Waste Plant planned for Kingmoor Park Industrial estate.

From my understanding of this proposal, it raises problems with local residents, proximity to schools, residential areas and would be a blot on the area.

I would like to object to it on the following grounds:

1. Design out of keeping with the character of the area

The size of the plant and chimney of 70m is on the scale of the civic centre, which dominates central Carlisle. To have an industrial building of this scale would impact greatly on local residents, the character of the area, it is also in very close proximity to Kingmoor nature reserve, Kingmoor nursery, infant and primary schools and a residential area. The Waste Resources Action Programme (WRAP) EfW Development Guidance recommends that EfW facilities should not be located within close proximity to residential areas, local schools or local nature reserves. WRAP provide information on best practice in waste management and recycling services to Local Authorities, amongst other organisations.

2. Dominant and oppressive environment created by the proposal

Considering the aforementioned size of the plant, and that it is situated at a high point in the city, it will have a significant and dominant visual impact for all those working in the industrial estate, for residents in parts of Lowry Hill and from locations in and around Kingmoor Nature reserve. That this plant will, despite reassurances from the developers, be emitting pollutants into the local environment, contributes to its oppressive nature, particularly for local businesses, local residents and visitors to the nature reserves.

3. Noise and air pollution

Considering that this plant will be running 24 hours per day and lorries will be bringing deliveries of waste across the 24 hour period the noise both from them and also the running of the plant is likely to cause disturbance to residents, particularly at night time. The National Planning Policy for Waste (NPPW) appendix B states the considerations waste planning authorities should consider. In its locational criteria it includes: "The operation of large waste management plants in particular can produce noise affecting both the inside and outside of buildings, including noise and vibration from goods vehicle traffic movements to and from a site. Intermittent and sustained operating noise may be a problem if not properly managed particularly if night time working is involved."

I am very concerned about the waste products from the plant. The very process of the plant converts products that are harmless into by-products toxic to the environment and human health. Although

the developers gave reassurances that products such as very toxic dioxins, heavy metals and others are prevented from entering the atmosphere, they are still produced in the gasification process, will remain in the waste product from the building and as such are therefore at risk of getting into the environment leading to documented negative health consequences. Once into the food chain the effect of dioxins accumulate to give more toxic impacts on human health. There will also be a large carbon footprint from the plant, not only in its emissions, but also in the emissions from its manufacture and the vehicle movements to and from it. An argument was given by the developers that it is better than putting waste in landfill from an emissions point of view but, following discussions with a waste management professional, I understand that the methane produced by landfill can be taken off and used so that it does not add to greenhouse gasses, and so does not provide an argument in favour of the EfW plant.

4. Impact on conservation areas and impact on local wildlife and biodiversity

The planned plant is situated only a few hundred metres from Kingmoor Nature Reserve. This is a special and accessible place for our community where many come, who maybe cannot travel further afield, to get closer to nature and the countryside. The visual intrusion of the plant will be of real detriment to this experience. I would also be concerned if any incident of environmental contamination from the plant impacted upon the flora, fauna and wildlife in the nature reserve, not to mention local residents.

5. Visual or Landscape Impact

The image shown on the picture of the plant as seen from Lowry Hill Road shown at the resident's meeting gave some idea of the size of it. There was an audible intake of breath in the room as people saw it. The plant is going to have a significant visual impact, from parts of Lowry Hill, from parts of the nature reserve, possibly Cargo, Crindledyke, and I would also expect from parts of Carlisle south of the river and Grinsdale looking north towards it.

6. Compliance with the Local Plan (i.e. Local Planning policy)

I note that the Mineral and Waste Local Plan for 2015 to 2030 is still in draft form. I am assuming that supercedes previous plans including the 2012 Site Allocations, Policies and Proposals map and would question therefore the current validity of the latter in terms of locating this plant as it may no longer be valid in relation to more recent national government guidance. Should any decisions on that front not wait until the new plan is approved bearing in mind that plan is for 2015 onwards?

Overall this is a really bad decision in a time when we need to look closely at our choices around what to do with waste and how to minimise environmental impacts. This plant will not create enough energy to warrant the impact from it on all the above points, I also understand there has been a high level of local objection which should be heeded, and other options explored.

RADIATION Free Lakeland Strongly Object object to the plans for the Energy Recovery Facility at Kingmoor industrial Estate in Carlisle. Recently the Development Control Committee unanimously voted to increase and continue the radioactive waste streams being directed to Drigg Low Level Nuclear Waste dump. Drigg routinely redirects wastes to Lillyhall landfill and no one monitors this but the nuclear industry. Lillyhall operators denied to Radiation Free Lakeland for many years that they were accepting radioactive wastes ...because they are "exempt". This is of course a weasel words denial as everyone now knows. The industry does its own monitoring of "free release" and "exempt" wastes and accidents happen to allow even hotter wastes into the waste stream.

1. Can the Development Control Committee guarantee that waste designated for Drigg would not end up in the incinerator in the same way that bags of low level and intermediate radioactive wastes have ended up in Lillyhall landfill? The nuclear industry monitors itself.
2. Can the Development Control Committee guarantee that tonnes of so called "exempt" radioactive wastes would not be directed to strategically located Carlisle from decommissioning at Scotland's Chapelcross and Dounreay ? The same applies to tonnes of radioactive rubble relabelled as "free release" at Sellafield, can the Committee guarantee this "free release" material would not end up in the incinerator. Remember that the industry monitor themselves.

Other concerns include:

A. Blight on character of the area

Plans to build a large building (approx. 40 metres) with a 70 metre chimney on the north of the city are massively out of character for a city whose primary attractions and future prosperity may depend on its ability to balance the types of economic development against its status as an historical city with great tourism and activity based growth potential.

Whilst zoned for industry the building and its use would also be significantly out of character for the types of business on the industrial estate. These are predominantly transportation, distribution, light metal fabrication, and offices. This industrial area also borders residential areas, and a retail area. The character of the building impacts negatively on the character of the area in all these regards.

B) Tourism would be blighted by an incinerator with the fear that this would be burning "exempt" nuclear waste. The operators will deny this as the Operators of the Lillyhall landfill site denied to Radiation Free Lakeland for many years our well founded accusations that they were accepting "exempt" nuclear wastes.

C) Food business which represent an important part of Carlisle's economy are also affected by this kind of development, as seen in the reasons for rejecting an Energy From Waste facility in Carmarthenshire recently.

The choice to build this facility at a high point of the city, visible from all the nearby housing and visible from miles around means that the presence of the building, the associated stigma of its activity impose on the environment of both the local homes and schools, businesses and the city as a whole. It will do so in such a way as that it can only be

characterised as dominant and oppressive, especially when you consider that it will be visible for miles around in all directions and that's from research I have conducted on plants in America that the smoke plume could be visible from as much as 20 miles away.

c) Visual or Landscape Impact

d) Excessive noise, dust, smell or nuisance, including the possibility of "exempt" nuclear wastes.

E) unacceptable risk for the 100000 people living on the East of this facility to take a risk on the skills, and probity of the developers. It is entirely reasonable for planning decision makers to take this into consideration. One mistake and the the city could be swathed in dioxins and other emissions which can cause cancer and birth defects.

F) Impact upon Conservation Areas or mature trees

Building this facility within a few hundred metres of Kingmoor Nature Reserve is inappropriate. This is England's oldest nature reserve and is deserving of the highest protection not just of its physical assets such as trees and wildlife, but also that the maximum amenity level should be retained. For those with limited mobility and the elderly, this beautiful woodland area represent a real escape into the wilderness on their doorstep. With the huge chimney planned, it will be visible form a large number of places in the wood, where no development is visible at present. Please protect our right to enjoy the privacy and peace of Kingmoor Nature Reserve.

G) Schools are close to the plants proposed site and with over 1000 new houses and therefore new schools likely. Councillors have responsibility for the health and well being of the people in the City of Carlisle.
