**Freedom of Information Act 2000 request: Empty Buildings**

With reference to your request for information, received 25 January 2013, made under section 1(1) of the Freedom of Information Act ('the Act'), I am writing to tell you that some of the information you require exists and is included below.

Please forgive the delay in responding. This was due to long term staff illness.

You asked the following:

*“ (a) addresses of any empty buildings (be it commercial or residential or industrial or storage facility etc) which belongs to yourselves*

*(b) addresses of any buildings (be it commercial or residential or industrial or storage) which belongs to yourselves, that are scheduled to be vacant in the next 12 months for whatever reason.*

*(c) if possible, type of use (eg. storage, office, warehouse, training, staff accommodation etc) of those buildings referred to in (a) and (b)*

*(d) if possible, approximate date (month and year) from which it became empty or will become empty, of those buildings referred to in (a) and (b)*

*(e) who in your organisation is in charge of the running of the estate or properties. ”*

Current vacant properties belonging to the College are:

One property at our Strand Campus.

Empty but currently under development by the College.

Use: D1.

One property at our St. Thomas' campus.

Empty but currently under development by Guy's and Saint Thomas' Trust.  
Use: D1.

One property at our Denmark Hill Campus is vacant at the moment (save two areas for storage, used by College).  
Use: D1.

College properties on Borough High Street and one on the Guy's Campus are technically empty, but under development.  
Use D1.

No College property is scheduled to become empty in the next 12 months.
