Dear Mr Hayes,

1. Thank you for your email of 17 June 2019 requesting the following information:

"I am requesting a document containing a record of all FOIA requests since 2014 where the British Army, Royal Navy or Royal Air Force are/ or were the lead branch. This document should contain the title of the request, a brief description, whether any information was released or not and the service that was lead branch".

2. I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (the Act).

## Information in scope

- 3. A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.
- 4. The information you have requested can be found in Annexes A-F attached to this response. Some of the information falls entirely within the scope of the absolute exemptions provided for at sections 40 (Personal Data) and 23 (Information supplied by, or relating to, bodies dealing with security matters) of the FOIA and has been redacted.
- 5. Section 40(2) has been applied to some of the information to protect personal information as governed by the Data Protection Act 2018.
- 6. Section 23(1) has been applied where the request makes direct reference to one of the security bodies listed at section 23(3) of the Act. Section 23 states:
  - (1) Information held by a public authority is exempt information if it was directly or indirectly supplied to the public authority by, or relates to, any of the bodies specified in subsection (3).

7. Sections 23(1) and 40(2) are absolute exemptions and as such there is no requirement to consider the public interest in deciding to withhold the information.

## Section 16 (Advice and Assistance)

- 8. Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the "Case Title" field of our database is completed by MOD staff and is used to provide a brief description of the request. We have therefore considered that this field, in the majority of cases, meets the department's Section 1 obligation under the Act for both the title and the brief description aspects of your request.
- 9. However, where the field was unclear, originally blank, or redaction of personal data would have left the field with no information, we have extracted a brief description from the full correspondence in order to meet the scope of your request.
- 10. In respect of the part of your request which asked "whether any information was released or not" for clarity I have provided a full description of the "Reported Outcomes" in the following table:
