Re: Information Request – Freedom of Information Act 2000

I can confirm that the NHS Information Centre for Health and Social Care (NHS IC) has considered your query dated the 8th April 2010.

"I would like to obtain a copy of all the information returned by Councils with Adult Social Services Responsibilities (CASSRs) as part of the Information and Guidance on the Grant Funded Services collection (GFS1).

For each local authority I would like to have the information contained in columns A-P (as arranged in proforma V1.4). These are all the columns except the 'Comments'. Please also include the local authority code for each scheme.

Please provide this information for the most recent period available.

If there is a choice between a 'cleaned' and 'raw' set of the information I would prefer the former.

Ideally I would like this data provided in a single spreadsheet or database."

Thank you for your enquiry. I am writing to inform you that the NHS Information Centre is considering if an exemption applies to some of the information requested. The exemption being considered is the 'Commercial interests' exemption, specifically Section 43(2) of the Freedom of Information Act.

This exemption requires The NHS IC to consider whether or not it is in the public interest to release the information. This is currently being assessed and in such circumstances The NHS IC is entitled to extend the 20 working day time limit set out in the Act by a reasonable timescale.

I estimate that we will be able to make a decision by the 7th June 2010. I will write to you as soon as possible advising you of the NHS IC's decision.
