Correspondence from the Information Commissioner states that:-

Performance & Support Services

"...the Housing Act 2004 states that the authority must ensure that the contents of the register are available at the authority's head office for inspection by members of the public at all reasonable times.

Publishing the register online means that this register, and its contents, are available to the whole world at any time and this is likely to go beyond the duty within the Housing Act.

As the register contains personal information then the authority also needs to be confident that it is compliant with the Data Protection Act 2018. Publishing the full register online is likely to be considered excessive under principle 3 of the DPA and therefore runs the risk of breaching the DPA."

A full version of the register is available to view at our Head Office, 1 Lancaster Circus, Birmingham, B4 7DJ. In order to access the full Register of House in Multiple Occupation licences, the Council requires proof of identity of the requester and a signed acceptance form that the **data shall be used only for personal, educational or non-commercial purposes.** Use for commercial purposes is not permitted.

You will need to make an appointment to view the register by contacting Mr Roy Haselden, HMO Licensing Team Leader on 0121 303 1470. A copy of the access request form is attached.

Please quote the reference number 3558467 in any future communications.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within 40 working days from the date this authority issued its initial response to your original letter and should be addressed to:
