Here are some comments on the above portrait in your collection.

THE SITTER: When the picture was sold at Christie's 8 June 1928, lot 100, it was described as Mrs. Shaw Barwell. It is not clear why the dealers, Arthur Tooth and Son, then changed the identification. Evidence is required to support the identification.

THE ARTIST: The picture was sold in 1928 as by James Northcote. Attributions at that time of portraits of this kind were notoriously unreliable. In my opinion, as author of "The Account Book of James Northcote", Walpole Society, vol. 58, 1996, this portrait is not by Northcote. It is not signed. It does not appear in the account book. The old claim that it is Gwynn no. 387, that is my no. 407, is untenable, since the portrait in

the account book was a head canvas, for which Northcote normally employed a canvas size 30 x 25 ins, rather smaller than your picture.

THE DATE OF THE PORTRAIT: I believe that the date allocated to your portrait of 1803 derives from the 1803 date in the account book of Gwynn no.387. To my eye the costume in the portrait seems rather earlier, perhaps about 1790, although I have not looked at this in detail.



Can you offer any opinion as to whether it, rather than our painting, is the Mrs Smith noted in Northcote's account book? The signature on our Mrs Smith looks the same on our other signed Northcote (we also have one of the Admiral Brooking portraits from 1803). Also, I note that Northcote's entry for Mrs Smith records "a head in Black drapery", which I think describes our painting better than the LA one. Any assistance on this point would be much appreciated.
