## Re: Injury on Duty Reviews; Essential Information

I have considered the situation of the forthcoming Injury on Duty (IOD) reviews and I suggest that the following information is the minimum that will be necessary in order to reach a fair and sustainable opinion upon each case:

- 1. The Occupational Health File which will include the previous SMP opinions and reports, including supporting medical reports.
- An up-to-date account of the medical situation. This would usually be the complete General Practice (GP) record including reports from hospital consultants. I note that some GPs are recently seeking specific consent to identify whether the whole record, or parts relating to a specific condition are released. In this situation the complete record is required.
- Recent medical reports from clinical specialists that may not yet be in the GP record.
- 4. A face-to-face meeting with the officer will be necessary in almost all cases. It must be possible to anticipate situations where medical circumstances are such that attendance for a consultation is not appropriate, but these are likely to be very few.

I appreciate that there will be individual circumstances and that some flexibility is always necessary, however it is essential that those retired officers involved appreciate that reviews can only be carried out where the entirety of the medical situation can be considered.

Where there is no consent for the release of relevant medical information, whether GP or OH notes, I will be obliged to inform the Service that I am unable to undertake a review or to provide the advice requested of me. You will be aware that, as an SMP, it is required of me to identify to the Service when an officer or retired officer is failing to engage with the process. Where available medical information is withheld, I am likely to take the view that this constitutes a failure to engage.

I will be happy to answer any further questions you may have; I will also be happy to discuss any difficulties that may arise from this advice.
