Internal Review: 32077

I am writing further to your e-mail of 15 July 2014 in which you asked for an internal review of our response to your Freedom of Information (FOI) request as set out in **Annex A.**

I have now completed the review. I have examined all the relevant papers and have consulted the policy unit which provided the original response. I have considered whether the correct procedures were followed. I confirm that I was not involved in the initial handling of your request.

The Home Office was entitled, at the time of your request, to cite section 12(2) of the Freedom of Information Act 2000 in relation to your request for a breakdown of the portion of fees paid to Treasury Solicitors for immigration and asylum cases. Invoices received in the Home Office regarding legal fees are not recorded by the type or matter of legal issue for which the advice and work was required. As such a manual search of our databases as well as our file records would be necessary in order to examine each invoice to clarify the class of work to which it related. This would take more than 24 hours.

In addition, the Home Office now notes that the response to the FOI request below (issued to you on 29 July) satisfies the request you made to the Home Office: https://www.whatdotheyknow.com/request/219003/response/544238/attach/html/2/RM%2060%2014.docx.html. As this information is in the public domain, and reasonably accessible to you, the Home Office is now exempt from providing you with this information by virtue of section 21 of the Freedom of Information Act. My conclusion is that the original response was correct and the response from the Treasury Solicitor's Department has made the information reasonably accessible to you.
