NOTICE is given that Cambridgeshire County Council intends after seven days, to make an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the effect of which is to stop any vehicle from proceeding along Granhams Road, Great Shelford as lies between points 20m either side of the railway level crossing situated there and as measured from its gates or barriers.

Access will be maintained to properties affected by this order.

The alternative route for vehicles will be via Granhams Road - A1307 - Hinton Way - Station Road - A1301 - Granhams Road and vice versa.

The proposed Order is necessary to facilitate essential maintenance works which are being carried out on or near this highway and it will come into operation on 5 January 2014 and continue until those works have finished or to the 4 July 2014 whichever is the earlier.

It is anticipated that these works will be carried out between 01:00hrs and 07:30hrs on 5 January and 19 January 2014.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform or of a Traffic Warden.

### **ORDER 2014/010**

WHEREAS Cambridgeshire County Council ("the Council") being the Traffic Authority for the highway known as Granhams Road, Great Shelford in Cambridgeshire are satisfied that the use of the said road should be restricted between points 20m either side of the railway level crossing situated there and as measured from its gates or barriers by reason of essential maintenance works being executed thereon or nearby.

NOW THEREFORE, the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along so much of Granhams Road, Great Shelford as lies between points 20m either side of the railway level crossing situated there and as measured from its gates or barriers.
2. This Order shall come into operation on the 5 January 2014 and may be cited as:-

3. It shall cease to have effect when the works have been completed or on 4 July 2014 which ever is the earlier.
4. The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform or of a Traffic Warden.
