Thank you for your email of 3 June in which you requested the following information:

reference FOI FOI2019/04619 made by RN Stebbings i was following this with interest then referencing F012018/05062 & F012019/04619 i noticed that you have refused the request due to *identifacation* issues

i would like to pose the same question so i might get the answer

you appear to have merged the questions so the *anwser* is confusing

can you confirm that the following is correct.

a, fewer than 5 in lincs ACF, but larger than zero

b,fewer than 5 in notts ACF, but larger than zero

could you additional also provide the results for the last 5 years in lincs.

Your correspondence is being treated as a request for information under the Freedom of Information Act 2000 (FOIA). Guidance from the Information Commissioner's Office (ICO) states that a valid request "must be in writing; include the requester's name and an address for correspondence; and, describe the information requested".

The ICO states that "the intention of the legislation is for the requester to provide their real name", and that "the absence of a real name would make it technically invalid under Section 8(1)(b)" of the FOIA. It should be noted, if an invalid request is processed by a Public Authority, the requester would have no recourse to the ICO as their powers only extend to valid requests under section 8 of the Act.

In view of the above and as the MOD has reason to believe that your request may be invalid, please would you provide us with identification, in the form of a copy of your driving licence or passport.

If you provide your identification as requested, we will be happy to take your request forward. More information on how to submit a valid request can be found at the link below:

If you have any queries regarding the content of this letter, please contact this office in the first instance. Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
