## Freedom of Information ref: 2016-IR41

Thank you for your request for an internal review of your Freedom of Information request 2015-5229.

You asked:

"I am writing to request an internal review of Department for Work and Pensions's handling of my FOI request 'Outcomes of WCA for claimants receiving treatment for cancer by way of chemotherapy or radiotherapy'.

I should have had a response more than a week ago, and I sent you a reminder"

In your original request you asked:

https://www.gov.uk/government/uploads/system/uploads/attachment\_data/file/439831/admu2.pdf, under U2025, the Example 4 shows that although a claimant is due to have radiotherapy treatment, the DM determines that she does not have and is not treated as having Limited Capability for Work.

I would like to know:

The number of claimants receiving treatment for cancer by way of chemotherapy or radiotherapy or likely to receive treatment within six months after the date of the LCW determination or recovering from treatment for cancer by way of chemotherapy or radiotherapy who were not found to have Limited Capability for Work, and therefore were not entitled to ESA

And the number of claimants in the same circumstances who were found to have Limited Capability for Work but not Limited Capability for Work Related Activity

Ideally I would like to have the total numbers from 28 January 2013 when the new rules took effect and including the most recent figures. If it exceeds the cost limit, could you narrow the search to only 2013, or/and 2014, or/and 2015 if the figures are available."

I am of a senior grade to the person who dealt with your request previously, and can confirm that I have carried out an internal review. In conducting my review, I have discussed the reasons why the original reply was late and the handling and the decisions made by the officer who handled it.

Your original request was received on the 20 December 2015 and a reply was due by the 20 January 2016. I can see that this has not happened and apologise for the delay in providing the response.
