Dear Ms Persson,

Thank you for your email of 14 April 2016 where you requested the following information:

I am making a freedom of information request regards higher education data.

"The AP student record is collected by HESA on behalf of the Department for Business Innovation and Skills (BIS) and the Higher Education Funding Council (HEFCE)." (Ref: https://www.hesa.ac.uk/component/studrec/show_file/15054/coverage.html)

Given that it is collected on behalf of BIS, I would like to ask for you to clarify at least part one of the question:

Does BIS currently (as of April 12, 2016) hold a copy of the following databases in part or as a whole and if so, how many individuals' records are in each that BIS holds:

Student records
AP student records
Destination of Leavers
Staff

Under the Freedom of Information Act 2000 ('the Act'), you have the right to:

- know whether we hold the information you require
- be provided with that information (subject to any exemptions under the Act which may apply).

I confirm that BIS holds copies of the databases referenced in your email. Details of how many individuals' records are in each database are enclosed in the appendix to this letter.

Details of the Alternative Provider Student Record, first collected in 2014/15, is withheld in accordance with Section 22 of the Act because this information is intended for publication at a

future date. Section 22 is a qualified exemption and we have therefore considered the public interest test.

Whilst the disclosure of such information leads to greater transparency in government, it does not outweigh the better use of public resources in preparing a single, accurate and more comprehensive presentation of the information in HESA's Statistical First Release (SFR). So, having considered the public interest test, the Department's decision is to withhold the requested information. The information will be published on 15th June and will be available on the HESA website – www.hesa.ac.uk.

BIS, like all government departments, takes its data security responsibilities very seriously. All data held is dealt with confidentially and information is only held if it is essential to performing our functions as a Department.

Appeals procedure

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original request and should be addressed to the Information Rights Unit:
