Hi Stephen,

Hopefully I can answer your questions on Owen's behalf:

**Q : As Terry Hone mentioned about actual saving figure on waste collection where did that come from ?**

**A :** Cllr Hone has been using this figure long before I arrived at HCC, the figure originates from the various studies that have been undertaken by the Herts Waste Partnership on developing an integrated waste collection and disposal model seen in other parts of the country. This saving will obviously be relevant to a move to a Unitary model, but did not originate through the recent PwC work.

**Q : On what date was the request made to PWC?**

**A :** The Director of Resources commissioned PwC in November 2019.

**Q : On what date was the request made to the Director of Resources to commission this work and by whom?**

**A :** The Director of Resources was asked to commission PwC on the 12 November 2019 by the Chief Executive.

**Q : One would assume PWC would have been sent a scoping document . I would like sight of that and the thus the terms of reference.**

**A :** Attached.

**Q : When was the document now circulated received back from PWC?**

**A :** The document underwent a significant level of challenge, review and quality assurance as both HCC and PwC wanted to ensure all comments and figures could be evidenced. The report was concluded and signed off in February 2020. For reasons that are obvious, the time was then not right to make the report public.

**Q : This was funded from the general consultancy budget . Was this reported to any members or Audit Committee?**

**A :** The commitment and then the spend was included in the detailed budget monitoring reports that support the quarterly monitoring process for officers and Members. The Leader and Resources Portfolio Holder were aware of the cost.

**Q : What other items have been commissioned from this budget and when ?**

**A :** PwC have been commissioned for a further piece of work to support HCC undertake the engagement stage around Local Government Reform in Hertfordshire. This involves the production of a further document to support the engagement, support as appropriate in undertaking the engagement, and help develop a proposal for Government if consensus is reached on a way forward. The cost of this commission is £40,000, with an option for further support depending on the level of engagement support required.

Stephen,

I have been tied up in an HR hearing today so have not had a chance to get to emails until now.

There has not been separate work done by officers on this previously although as you would expect there was some officer engagement with PWC as this report was prepared.

Following this initial report, we have recently been working with PWC on how to follow up the initial report. The statement David released yesterday calls for engagement on the subject of potential LGR, and so we are now doing some work with PWC to develop materials on the best way to do that engagement in Herts. That is work in progress, but given the need to engage with all stakeholders, that will need to be completed soon and so it will then be shared.

Scott can provide details of the commercials on that follow up work if you would like to see it.

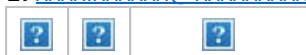

Stephen,

I'm not aware of the process by which a report produced by PWC was commissioned but I would note that Executive Directors have delegated authority to make expenditure and commission advice.

As for confidentiality it isn't uncommon for work to be undertaken for groups, both administration and opposition on a confidential basis. For example when developing the budget proposals, both administration and opposition receive dedicated support in respect of developing plans/proposals. This will be confidential and indeed the confidentiality is enshrined in the constitution.

The FoI legislation also recognises this as it contains an exemption specifically for the circumstances of policy development and also where information is due to be released in the



near future.
