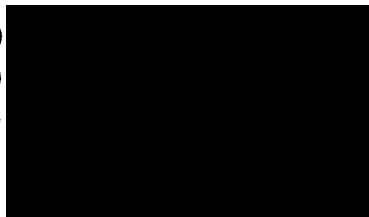

As a result of the application

**IT IS ORDERED** that;

- 1) The above-named Respondents whether by themselves, their servants or agents, or otherwise, be restrained from committing a trespass on the Claimant's land by being or remaining or entering upon any of the properties as are listed and referred to by address in the Schedule attached hereto, and from returning thereto without the written permission of the Secretary or Director of the London Metropolitan University save for the purpose of attending courses and examinations for which the Respondents are scheduled or library study in connection with such courses or examinations or attending for the purpose of executing their proper duties as sabbatical officers until trial or further Order.
- (2) The above-named Respondents whether by themselves, their servant or agents, or otherwise, be restrained from inducing, inciting, causing or encouraging any person to trespass on any of the properties as are listed and referred to by address in the Schedule attached hereto until trial or further Order.
- (3) That upon service of this Order each of the Respondents shall forthwith cease to occupy any of the properties as are listed and referred to by address in the Schedule attached hereto.

- (4) Liberty to all Respondents to apply to vary the terms of this Order on 24 hours' notice to the Applicant's Solicitors and to the court in writing.
- (5) That the above injunction shall continue until further Order
- (6) The costs of this application be reserved
- (7) That the Applicant do serve this Order by attaching same to some part of each of the properties as are listed so that they are clearly visible and inserting the Order and the evidence in support of the application in a sealed transparent envelope addressed to "the occupiers" through the letter box to or under any access door to the occupied part of the premises.

## **GUIDANCE NOTES**

### **Effect of this Order**

A Respondent who is an individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.

### **Variation or discharge of this Order**

The Respondent (or anyone notified of this Order) may apply to the Court at any time to vary or discharge this Order (or so much of it as affects that person), but anyone wishing to do so must first inform the Applicant's legal representatives.

### **Parties other than the Applicant and Respondent**

#### **Effect of this Order:-**

It is a Contempt of Court for any person notified of this Order knowingly to assist in or permit a breach of this Order. Any person doing so may be sent to prison, fined or have his assets seized.

### **Interpretation of this Order**

- (1) In this Order, where there is more than one Respondent, (unless otherwise stated) references to "the Respondent" means both or all of them.
- (2) A requirement to serve on "the Respondent" means on each of them. However, the Order is effective against any Respondent on whom it is served.
- (3) An Order requiring "the Respondent" to do or not to do anything applies to all Respondents.
