

CERTIFICATE OF REASONS FOR BRINGING A POSSESSION CLAIM IN THE HIGH COURT

- I am James Fownes, Associate Solicitor of SGH Martineau LLP of No.1 Colmore Square, Birmingham B4 6AA. I make this certificate in accordance with Part 55.3(2) of the Civil Procedure Rules to certify the Claimant's reasons for starting this claim in the High Court.
- The Claimant is applying to the High Court for an interim injunction to restrain acts of trespass by the Defendants on the city centre campus of the Claimant.
- The application is urgent for the reasons stated in the Witness Statement of Brendan Casey dated 22 November 2013. In summary, there is a potential danger to health and safety as a result of the occupational 'sit-in' trespass upon the Campus.
- It is appropriate to issue the possession claim in the same Court as the injunction application in order to avoid the duplication of costs and unnecessary use of resources in two different courts.

WITNESS STATEMENT OF BRENDAN CASEY

I, BRENDAN CASEY of the University of Birmingham, Edgbaston, Birmingham B15 2TT will state as follows:-

- I am the Director of Academic Services with responsibility for provision of a range of student services, including Registry, Library, student conduct and welfare matters at the University of Birmingham (the "University") and am authorised to make this Witness Statement on behalf of the University in support of the University's application for an order for summary possession and supportive Injunction, as set out in the Application Notice herein dated 22 November 2013.
- Insofar as the facts and matters referred to herein are within my own knowledge, they
 are true and in so far as they not within my own direct knowledge they are true to the
 best of my information and belief, acquired in the course of acting in my capacity as
 Director of Academic Services for the University.

THE UNIVERSITY

3. The University of Birmingham is a leading centre for the study of a wide range of subjects with a good international reputation. The University has more than 28,000 students, 40% of whom are on postgraduate or research programmes. The University has also has also just been awarded status as University of the Year by The Times and The Sunday Times.

THE CAMPUS

- 4. The University's main campus is in Edgbaston in Birmingham. I shall refer to this main campus throughout this Witness Statement as "the Campus". The Campus is shown edged red on Plan Battached to the Particulars. Blocks A and B of the Aston Webb Building ("the Building") are shaded green on Plan A, which is the land subject to these proceedings.
- The University is the freehold proprietor of the Campus, which is registered with title number MM6820.
- As University property is private land, only persons with the licence or consent of the University may enter or remain on the Campus.
- The Building is one of the most iconic on the Campus and is a multi-use/occupancy building. The Building houses:-
- 7.1 The Senate Room, where a range of University bodies and committees host their meetings, including the Senate and Audit Committee. The use of this space requires pre-booking and necessary authorisation from the University;
- 7.2 The Great Hall and Brammall Concert Hall, which both host a number of large conferences and events throughout the year;
- 7.3 Lecture rooms, teaching rooms and research labs, which are consistently utilised throughout the academic week; and
- 7.4 The IT and telecommunications infrastructure for the University.

THE STUDENTS AT THE UNIVERSITY

8. The University places a high value on providing its students with a fulfilling education in their chosen discipline. There are a wide range of activities on the Campus and the Campus environment is the focal point for the lives of students attending the University. We therefore seek to ensure that our students have the right environment on the Campus to enable them to settle in and study effectively in a safe environment.

THE OCCUPATION/PROTEST

- 9. At approximately 7:00pm on Wednesday 20 November 2013, security officers attended the Building to properly close and lock up the Building. They discovered that a group of twenty hooded and masked individuals, who are believed to be students of the University gained entry blocked off and locked a staircase and locked themselves inside a cluster of rooms primarily in the semicircle, and partly in Blocks A and B of the Building, including the Senate Room
- 10. The Defendants do not have the permission or consent of the University for the purposes of the protest and they are trespassing.
- I attended the Building shortly after receiving a call from the Head of Security [at around 7:30pm, along with the Registrar and Secretary of the University, the Director of Legal Services, and Director of Student Services. I was able to identify two of these students over the 36 hours, being Simon Furse, who is a third year undergraduate and Hattie Craig, who is an undergraduate and a Trustee of the Guild of Students.
- From looking at CCTV footage, it is thought that the students gained access from the lower ground floor from the Grange Road direction of the Campus.
- 13. The students have blocked various fire exit routes and staircases out of the building in the vicinity of the Senate Room. The fire exit doors have also been locked from the inside, which places the students at risk in the event that there is a fire.
- 14. The students have also blocked access to teaching areas (lecture rooms and research labs) in the Building which has forced us to reschedule various seminars and lectures. This is causing severe disruption to the teaching timetable and will lead to further postponement of lectures and other academic events. This is clearly affecting other students at the University given that they are unable to attend the lectures for their courses, and such disruption has the potential to affect National Student Survey results and the reputation of the University at a time when recruitment is extremely challenging.

DISRUPTION

15. Furthermore, the students have also forced the closure of the switchboard for the entire University, which at first prevented all incoming and outgoing calls. The University however managed to relocate the switchboard shortly thereafter. In addition it also forced the temporary closure of the university's Telecommunications Office, which forms the backbone of the communications in the event of an emergency on campus. Given that there are a number of events scheduled to take place over the next few

- days, this is causing immense logistical difficulties, particularly for those attending such events. Generally, and most importantly, the closure of the switchboard is affecting the commercial operation of the University.
- In particular, the University is hosting its annual Post-Graduate Open Day ("the Open Day") on Wednesday 27 November 2013 in the Great Hall, which is immediately adjacent to where the protest is taking place in the Building. Last year, over 2,000 attended this event, where 1,850 people pre-registered to attend and 350 additional persons arrived on the day. The University already has 2,700 people pre-registered to attend the Open Day, and expect an additional number on the day. Over 60% of those attending come from outside of the University; either from other Universities or overseas.
- The enrolment of post-graduate students is very important to the financial viability of the University, particularly in these demanding economic conditions. Clearly, this occupation will negatively affect the Open Day, as the University will be required to relocate the event, which will be logistically very difficult given the number of visitors that will be attending. Furthermore, a relocation of the Open Day will mean that it will not be held in one of the most iconic buildings on the Campus, which is a good selling point for the University.

TRESPASS

- 18. The Director of Legal Services issued a letter on 20 November 2013, to the occupiers by hand informing them that they were trespassing, in breach of Regulation 8 of the Student Conduct Regulations and that the University required them to vacate immediately. A copy of this letter is exhibited at "BC1".
- 19. The main method of communication with the occupiers has come through reading the social media channels through which they have communicated the occupation and the purpose thereof. Copies of these are exhibited at "BC2".
- Further, the protesters have asserted their intention to remain in occupation in an interview with The Independent. A copy of this article is exhibited at "BC3".
- 21. The occupiers have refused to engage with the University, and their only method of communication to us has been through the use of social media, and some dialogue through the Guild of Students.
- 22. The Director of Legal Services sent a further letter on 21 November 2013 at 10:30am to the occupiers to inform them of the concerns of the University in respect of health, safety and fire risks. The letter also confirmed that their occupation of the Senate Room and adjoining area is considered as a trespass and to leave the Building immediately. A copy of this letter is exhibited at "BC4". No response was received.

23. Therefore, on 21 November 2013 at 6pm, a final letter was sent to the occupiers from the Director of Legal Services, which was delivered by hand requesting that they vacate the premises by am on 22 November 2013. I set this deadline in order that the vacation could take place in daylight as I felt this would be safer than a vacation in the dark at night. The letter also set out that if they did not leave then the University reserves its right to exercise its legal options. A copy of the letter is exhibited marked "BC5". The deadline has now passed and despite the University's continued attempts to deal with this situation reasonably, the occupiers remain in situ.

HEALTH AND SAFETY AND FIRE RISKS

- On 20 November 2013, I considered it best to obtain an expert opinion from the University's, Assistant Director of HR (Workplace Wellbeing), Leslie Wright, who is a Chartered Fellow of the Institute of Occupational Safety and Health. He confirmed that the occupation of the students and refusal to leave the Building is breaching the University's Health and Safety Policy (the requirement for them to co-operate with the University in any matters related to their health and safety). Furthermore, the deliberate obstruction with the fire escape routes also breaches this policy, as this presents a risk to personal safety given that it would delay evacuation, particularly to those students occupying the Building. The Assistant Director of HR at the University therefore issued a note on health and safety to the occupiers in the Building at 2pm on 21 November 2013.
- 25. The University accepts that Universities are places of free speech and respects the rights of students to protest peacefully and within the law. The University's priority is the safety and wellbeing of students, staff and visitors, and it is concerned that any protest poses a potential hazard to protesters, staff and bystanders or cause unwarranted destruction or damage to property. The University has endeavoured to agree a Protocol with the University Guild of Students governing student protests and a copy is attached at "BC6". This remains a draft as this has not been acknowledged by the University Guild of Students.

THE BUILDING

26. In addition, it is apparent that the protesters have deliberately targeted the Building, as it is an important decision-making forum, which is located in the central hub of the Campus. It is also apparent that the protesters have deliberately commenced this occupation in this Building in order to seek to bring maximum disruption to the University. The occupiers acknowledge the significance of the Building to the University's operations and decision making in their Statement on the Occupation of Senate Room at "BC2".

- 27. In light of the above and given the central location of the Building on the Campus, I consider that the occupiers would easily be able to occupy neighbouring buildings on Campus if they are permitted to continue their protests and occupation.
- 28. I felt that in these circumstances the University had no choice but to seek a summary possession order and further supportive injunction.

THE INJUNCTION POSSESSION ORDER SOUGHT

- 29. The University in negotiation with the Guild has an agreed protocol to facilitate orderly protest by the student body and has a similar arrangement with the trade unions that represent employees of the University. Occupation is not allowed under the protocol and, indeed, the occupiers have never sought to invoke the protocol in anything that they have done.
- 30. The occupiers have no right to conduct a 'sit-in' as they are doing. This taking of occupation upon University property is a trespass which extends well beyond the terms on which students are entitled to access upon University property. Furthermore, no student of the University should engage in activity likely to interfere, in the broadest sense, with the proper functioning or activities of the University or those who work or study in the University or undertake action which otherwise damages the University.
- 31. There is already a risk to health and safety as a result of the unauthorised occupation by the protestors. As others may be encouraged by the occupiers to join the protest, this situation might get worse. My concern is that there is a general risk to the building through the occupation, and to the occupiers themselves, which may worsen if the occupiers remain in occupation.
- 32. In light of the situation which I have described I respectfully request on behalf of the University, a summary order for possession pursuant to CPR Part 55 together with an injunction in the terms of the draft Order attached to the Application Notice dated 22 November 2013. I respectfully request the Court to grant an order which protects and covers the entirety of the Campus (which is effectively the one site, and not separate pieces of property), notwithstanding that the 'sit-in' occupation is currently part of Blocks A and B of the Building to which I have referred. If the Defendants are forced to move from one part of the Campus only, then it is highly likely that this will only result in them moving to another part of the Campus.
- I also request the Court to grant orders which effectively abridge the time for service of these proceedings to Monday 25 November 2013 in view of the urgency of the situation. I leave the mechanics and procedural basis for that to our lawyers, but I am confident that such service as they have devised (and which has been discussed with me) will come to the attention of the protesters. I have concerns that the occupiers may resist any other form of service.

UNDERTAKING IN DAMAGES

34. If it is necessary (and I understand it may not be) I am able to confirm to the Court that the University is able and willing to provide an undertaking in damages. Again, if necessary, I am authorised to give this undertaking up to the sum of £25,000, but I can seek authority to give an undertaking in a larger sum if necessary. Obviously, if a final order is granted this will not be required. I cannot envisage any circumstances where significant damages would arise to the students in any event.

35. I believe that the facts stated in this Witness Statement are true.



Statement from the occupation- why we need a democratic university

The mere suggestion that universities should be democratic is often viewed with incredulity or suspicion. When asked in a debate about whether the University of Birmingham should be more democratic the Vice Principal Adam Tickell said that he didn't think that the university should become a soviet republic and that the most important thing was "good governance" (him in charge). This article aims to set out why universities should be democratic and the severe dangers that result in putting higher education in the hands of university managers, the government, and the economic elite.



Different Forms of Co-ordination

Education has to be co-ordinated in some way, and if we do not chose democracy and self-organisation then the alternatives are either hierarchy and command or the market/exchange. Most systems of co-ordination mix these three mechanisms to greater or lesser extent. The current system of Higher Education is primarily a mixture of hierarchical and market forms of coordination. Internally the university is extremely hierarchical, Vice Chancellors have more concentrated power than a CEO of a publicly limited company, without even accountability to shareholders. Externally they must compete for students, and research grants on a quasi market. But the rules of the game are commanded down by the government.

What mechanism we choose for running education, fundamentally depends on what kind of education we wish to have. Education will obviously reflect the priorities of those who have control over it, and will tend to reproduce

.ich it is run. Education is of fundamental importance to society as a whole as it determines the upon which our society is based and the way that it develops.

ortance of education

the importance of emancipatory ideas and struggle in society cannot be overstated. The last few hundred years of European society has truly shown us the incredible horror and brutality that can be produced by unchecked power structures, deference to authority, and oppressive ideas. After the horrors of the first half of the 20th century the idea that the primary function of education should be to create reflexive individuals willing to challenge power was widespread. This is a lesson that has clearly not been learnt, but that we forget at our peril.

When education is accessible to everyone, and left to primarily self governing mechanisms (or even often without them) it almost always tends towards creating emancipatory ideas and action. Education allows us to analyse the world around us and gives us tools with which we can change it. It takes exertions of power to take education away from these sort of ideals, to repress people's free desires for a better society. Marketised education <u>does not make sense</u> if you analyse it in terms of doing better research or teaching people better; the reforms are about creating different kinds of graduates, ones that fits more productively into the society that they wish to create.

Education for the market

One of the clearest examples of the marketisation of education is the creation of information on how many students on each course at each university pay back their loans. David Willets <u>has said he finds it "incredibly frustrating"</u> that these measures do not already exist. What this means is a total subordination of university to the interests of business. Universities will be judged not on the intrinsic, or educational value of their degrees but on the extent to which their graduates are valued by the market.

A marketised education system means that students lives are controlled by our future employers, not just when we are in work, but constantly as we must jump through hoops to gain the upper hand over other students. This hollowed out life- being constantly forced into things that are good for the CV- is categorically opposed to real education and learning.

Education for the government

The current reforms, and the general process of neoliberalisation within universities, also empowers the government to set their own priorities for education (often almost indistinguishable from those of business) ahead of those who work and study in it. The government is increasingly intruding on any idea of education as a free exchange of ideas. Last week we learned that <u>Michael Chessum was arrested</u> for protesting without the permission of the state, and that the police had <u>attempted to spy</u> on student activists from Cambridge.

This trend towards violence against students follows far more serious violence and incitement by the state against various oppressed groups. The attack on benefit claimants through atos assessments, sanctions and workfare, and the government's unbelievable dehumanisation of immigrants are truly horrifying signs of the kind of society we need to avoid.

If we are to take ideas, debate, and a decent society seriously, then education should stand as a clear challenge to the government, not a capitulation to it. David Eastwood, the Vice Chancellor at Birmingham, has cheered marketisation in, every step of the way. He was on the Browne Review that set fees at £9,000, he writes in the Guardian arguing that the problem with higher education is too much public involvement, and last year he did a fringe event at Tory party conference arguing that universities should be setting up free schools. The idea that he is the best person to guard something like a university is frankly laughable.

he alternative

Our Demands set out a number of very moderate ways in which the management of the University of Birmingham could stop attacking the interests of staff, students, and the community. Whether it is lobbying against our interests, closing vital courses because they don't fit the universities' "strategic vision", squeezing as much profit out of students as they possibly can, or a culture of secrecy and attempting to outcompete other universities; the senior management continually shows no regard for the community whose work they depend on.

Education is far too important to be left to the likes of David Eastwood and David Willets. The urgent task of everyone involved education should be increasing the power of students and staff to shape the way it runs.



We demand:

Free and open access to the occupation by all students and non-management staff, without victimisation or punishment. Senior management staff should be excluded from entering the occupation so that it can remain a strong and safe organisational space.

That David Eastwood and the University of Birmingham should publicly take back their position that fees should be increased and that bursaries should be cut. Instead, they should lobby the government for fees to be reduced, and bursaries to be increased.

at the University of Birmingham make a public statement against the privatisation of student loans and in defence of the public university. The Vice Chancellor should sign up to the Council in Defence of British Universities or the Campaign for the Public University.

That the University's total income per student place from halls should be frozen next year, and that the cheapest fifth of halls should have their prices decreased.

That all staff working for the University of Birmingham- including those employed in house, by external contractors, and the Guild of Students- should be paid a living wage.

That the pay ratio between the lowest paid and the highest paid staff in the university should be reduced to 10:1.

That a body should be set up made up of elected students, academic staff, and support staff. This should have ultimate oversight over the restructuring of departments, the University's investment decisions, and its lobbying positions.

That the University produces a publicly available Ethical Investment and Procurement Policy which is reported on annually with plenty of opportunity of engagement with staff, students and other key stakeholders.

ancial statements of the University's academic departments, and non-academic services should be ed so that they can be scrutinised and the University's decisions be properly held to account by the ammunity.

That the Nursing course faces no loss of investment and no redundancies.

That the University should allocate none of its access income to compulsory fee waivers and instead spend it all on Bursaries, or give students the choice.





keep them going through the night.

In a statement, the protesters hit out at university management, for allegedly decreasing students' power and representation.

"Defend Education believes that staff and students should have more power in every level of university decision making. Currently a small class of senior managers benefit disproportionately from the fees and work of staff and students. They have total

unaccountable power to harm our interests within the university and lobby against our interests outside it."

The group has published a list of their demands online. They want the university to campaign against increased fees, to guarantee all staff, including casuals, the Living Wage, and to decrease the pay disparity between the highest and lowest paid employees. The full statement is available here.

The occupation is ongoing, and a spokesman for the group told The Independent that they have "no plans to leave".


"We're trying to assert control over a situation where students feel they have no power. The response has been amazing. Security are not letting anyone else in but we know more people want to join."
