Thank you for your email of 12<sup>th</sup> March 2021. You made the following requests for information:

I understand you have a knowledgebase/repository that Family Court Advisors access. Can you please provide me with:

- A list of all the files in the knowledgebase relating to "parental alienation" or psychological child abuse after parental separation? \*

The training we have which covers parental alienation is our Child Impact Assessment Framework Training (or CIAF training for short). The files are publicly available on our website, and can be found here: <a href="Child Impact Assessment Framework">Child Impact Assessment Framework</a> (CIAF) - Cafcass - Children and Family Court Advisory and Support Service

This also forms part of our induction training for people new in post. There is also access to a psychology service to discuss cases with a qualified psychologist if it is felt necessary by a Family Court Advisor in a case where parental alienation is present.

We are unable to provide a response as it is not recorded at Cafcass.
