Thank you for your e-mail of 7 January, in which you ask for information regarding the processing of Zambrano cases. Your request has been handled as a request for information under the Freedom of Information Act 2000.

You have requested the following information;

Please note, you have requested information regarding rejected applications. Rejected applications are cases that have not been considered usually because part of the application or processing fee was incomplete.

How many applications are currently outstanding?

There are 595 Zambrano applications currently outstanding.

What is the average processing time for Zambrano applications?

4.7% of the applications were granted.

How many were rejected?

4 applications were rejected.

How many appeals have the Home Office lost?

Of the appeals the Home Office lost, how many has the Home Office applied for permission to appeal?

Of the applications for permission to appeal, how many were successful in the appeal being granted?

Of the applications which went on to further appeal, how many applications were overturned in the Home Office's favour?

How much does the average case cost the UK taxpayer for the Zambrano appeals?

None of the rejected applications appealed against the decision.

How many of the rejections were by black single parents? And asian single parents? What percentages do they constitute?
