## Freedom of Information request (reference number: 33710)

Thank you for your email of 3<sup>rd</sup> December 2014 where you asked for information regarding legal expenditure in relation to immigration and asylum. A full copy of your request can be found in the attached annex. Your request has been handled as a request for information under the Freedom of Information Act 2000. I apologise for the delay in responding.

I can confirm that the Home Office holds in the information you requested, however we are only able to provide the litigation costs for the years specified.

The figures above show the litigation expenditure in relation to immigration and asylum. Because of the way data was recorded in the past, it is not possible to provide information on a comparable basis for 2010-11 due to differences in financial reporting structure at that time.

Please note that the figures provided include litigation costs for the entire immigration and asylum group, for example, the costs for commercial disputes and HR cases, as well as other functions. It is not possible to break the expenditure down further without exceeding the cost limit.

You have additionally asked whether the Home Office pays Counsel directly. The usual practice is for Home Office to pay TSol a sum including fees for Counsel, rather than for the Home Office to pay Counsel direct.



In keeping with the Freedom of Information Act, we assume that all information can be released to the public unless it is exempt. In line with normal practice we are therefore releasing the information which you requested via the Home Office website.

If you are dissatisfied with this response you may request an independent internal review of our handling of your request by submitting a complaint within two months to the address below, quoting reference: **33710**. If you ask for an internal review, it would be helpful if you could say why you are dissatisfied with the response.
