Question 1

Please could you provide details of how many people have been

- (a) arrested for
- (b) prosecuted for and
- (c) convicted of vice-related offences in Northern Ireland for the year 2014 and if possible the gender and age/age-range of the persons.

Vice-related offences are:

Loitering or Soliciting for Prostitution Trafficking for Sexual Exploitation Causing, Inciting and Controlling Prostitution for Gain Keeping a Brothel Paying for Sexual Services.

In regard to trafficking for Sexual Exploitation, if possible can you specify whether the case related to prostitution or not.

Answer

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested and the response is as follows.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
