

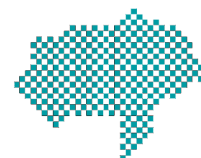

I write in connection with your request for information which was received by the Office of the Police and Crime Commissioner on 11 October 2016. Please accept our apologies for the delay in providing you with a response. I note you seek access to the number of applications received and persons interviewed for the role of the North Yorkshire Deputy Police and Crime Commissioner.

Extent and Result of Searches to Locate Information

To locate the information relevant to your request searches were conducted within The Office of the Police and Crime Commissioner and I can confirm that the information you have requested is held.

Decision

I have today decided to disclose the located information to you.

16 applications were received for the role of the North Yorkshire Deputy Police and Crime Commissioner;

4 people were shortlisted and invited for an Interview;

2 of those shortlisted withdrew prior to an interview and 2 applicants were interviewed;

1 person was selected and offered the position of the North Yorkshire Deputy Police and Crime Commissioner.

Please note that systems used for recording information are not generic, nor are the procedures used locally in capturing the data. It should be noted therefore that this force's response to your questions should not be used for comparison purposes with any other responses you may receive.

COMPLAINT RIGHTS

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require the North Yorkshire Police to review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision of the North Yorkshire Police made under the Freedom of Information Act 2000 (the Act) regarding access to information you can lodge a complaint with the North Yorkshire Police to have the decision reviewed. North Yorkshire Police must be notified of your intention to complain within 2 months of the date of its response to your Freedom of Information request. Complaints should be made in writing and addressed to:

In all possible circumstances the North Yorkshire Police will aim to respond to your complaint as soon as practicable but within 20 working days.

The Information Commissioner

After lodging a complaint with the North Yorkshire Police if you are still dissatisfied with the decision you may make application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
