Dear Mr Davis

On 4 June 2010 you asked for "the number of Equipment Failure Reporting System reports that have been lodged in each of the years from 2005 onwards broken down by the different kinds of weapons in operations". On 14 June 2010 you clarified the question as referring to "all guns, rifles and machine guns either hand-held or mounted on tanks, armoured vehicles or aircraft". This is regarded as a request for information under the Freedom of Information Act 2000.

The Equipment Failure Reporting System (EFRS) only provides information for Land based equipments and does not cover those for Air (or Maritime) platforms. The EFRS is administered through the Failure Reporting, Analysis and Corrective Action System database (FRACAS). For those equipments where an Equipment Failure Report has been received, the number of reports held on the database, for the period 2005 to date, is provided in the attached spreadsheet.

The Equipment Failure Reporting System (EFRS) is the mandated system for equipment users to report failures, such as accidental damage, maintenance related failures and breakdowns. It does not incorporate the results of subsequent investigations and therefore does not differentiate between what might later prove to have been a problem caused by operator error or damage sustained as a result of operations. Nor does this data record the severity of a failure which might have no discernible impact on operational capability or safety.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Head of Corporate Information, 6th Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the internal review process has been completed.
