Information Request

Thank you for your request for information, which was received on the 11 May 2017.

As this is a request for environmental information, it has been handled in accordance with the Environmental Information Regulations 2004 (EIR). EIR is broadly similar to the Freedom of Information Act, but specifically applies to environmental information.

In order to close this request, you sought the following information:

A. Confirmation that the information provided on 27 March 2017 [drawing FMW0125-SPA08] was NOT submitted by the Developer and/or approved in writing by the Council PURSUANT TO Schedule 2 [1.1] of the s.278 Agreement dated 20 January 2014. [If it WAS ever formally submitted and approved in this regard, please provide copies of the relevant information].

B. Confirmation that on the date of the original request [3 March 2017] the Council held NO relevant information, i.e. DETAILS submitted and approved PURSUANT TO Schedule 2 [1.1] of the s.278 Agreement [other than that described at A above if appropriate]. If the Council DID hold any/further information, please provide copies without further delay.

C. If the Council holds any information relevant the request that is dated AFTER 3 March 2017, please provide copies.

If the Council fails to provide any sort of meaningful response to the above by 19 May 2017 [at the latest] I will ask the Information Commissioner to investigate the matter.
