Your email dated 11 October 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

I own an Ex-RAF Land Rover Defender 110 which I believe was stationed at RAF Markham before "retiring".

Under the Freedom of Information Act, please can you provide me with the vehicle's full Military Service History? The military registration is 29 KL 38 and Serial No. is SALLDHAC7LA935712.

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

This information supplied to you continues to be protected by copyright.
