Information on arrears is only extracted for Employment and Support Allowance (ESA), but is restricted to aggregate amounts paid out across all ESA arrears payments nationally and does not help to answer your latest or previous question concerning numbers of back-payments for official error on conversion of Incapacity Benefit to ESA.
