## LONG TERM PRODUCTION CONSENT

### PETROLEUM PRODUCTION LICENCE No(s). PL235 DEVELOPMENT AND PRODUCTION WORKS

1. The Oil and Gas Authority hereby consents, for the purposes of paragraph (1) of Model Clause 15 of the Model Clauses incorporated into Petroleum Production Licence No. PL235, to
  - (a) the erection or carrying out during the period commencing on 29th October 2017 and expiring on the earlier of 28th October 2019 and the date of expiry of any above mentioned Licence(s) ("the period") of the relevant works (as defined for the purposes of the said Model Clause(s)) described in the documents entitled "Licence PL235 - Brockham - Annex B" dated August 2000, "PL235 Brockham - Field Development Plan Addendum" dated April 2015 and "Brockham Kimmeridge Reservoirs - Addendum to the Field Development Plan" dated September 2017 (which documents together comprise "the Development Plan"), as varied by any subsequent modification to which the Oil and Gas Authority has given written consent, as being relevant works to be erected or carried out during the period for the purpose of getting petroleum from those parts of the licensed area known as the **BROCKHAM** Field ("the field") or for the purpose of conveying, to a place on land, petroleum got from the field; and
  - (b) the getting of petroleum from the field during the period by means of those relevant works as are indicated in the Development Plan as works from which petroleum is intended to be got.
2. This consent is given on condition that:
  - (a) any development carried out pursuant to this consent is carried out in accordance with the proposals contained in the Development Plan, as amended from time to time with the agreement of the Oil and Gas Authority;

- (b) during each year specified in the Schedule hereto the quantity of petroleum got from the field is not greater than the maximum quantity in respect of that year; and
  - (c) in the event that any further viable development is identified within the field area (an "incremental development"), the Licensees having had an opportunity to make representations to the Oil and Gas Authority, shall:
    - i. within nine months of the date on which the incremental development is identified, propose amendments to the Development Plan so that it provides for the incremental project to be carried out;
    - ii. incorporate the amendments in the Development Plan, subject to any modifications the Oil and Gas Authority may specify; and
    - iii. carry out the incremental development in accordance with the Development Plan as amended.
  - (d) In addition, this consent is granted subject to the following further conditions:
    - i. Any gas produced must not be wasted and must be produced for value;
    - ii. Production of gas shall only take place at such times that there is a sufficient and functioning electricity generation facility and a connection to the local electricity distribution grid;
    - iii. Any gas produced shall be used to efficiently generate electricity at the Brockham Oil Field site;
    - iv. Any excess electricity generation beyond what can be usefully consumed onsite must be exported to the local electricity grid.
3. This consent is given for the purposes of paragraph (1) of the said Model Clause 15 and without prejudice to the operation of any other provision of the licence(s) or otherwise.
