Your email dated 4 December 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

Provide me with the vehicle's full Military Service History and any other documentation associated with the vehicle? The military registration is 27 KL 33 and Serial No. is SALLDHMF7LA933931

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.
