Hi all,

Please find attached the updated results from the recent survey we did. I've also attached a copy of the DFE letter we looked at regarding the suitability of provision. I'll send the pdf's of the work submitted by the family for context. I'll do them in two emails as they are quite large. The material mum sent was supposed to cover a period from Jan – Nov 2015. I did a visit in October 2015 and saw some work but didn't think the provision was full time. Prior to this meeting mum stated that she had all his work and was supposed to have it ready for the meeting. I saw her again in November 15 and was presented with work seen at the previous visit and no real work that had taken place between October to November, let alone Jan-Nov. She disagreed and went to the DFE. I stated that the evidence was neither full time or suitable to his needs and after around 4 months they came back with their decision. Alongside this work mum sent in weekly timetables and educational philosophy's regularly. The DFE saw all work, timetable's, plans, etc. I think this shows we can expect more than we probably think we can.....
