Environmental Information Regulations 2004

Your request for information has been considered by Warwickshire County Council under the Environmental Information Regulations 2004.

I am writing to advise you that the information you have requested is not held by Warwickshire County Council. Therefore regulation 12(4)(a) applies to your request. Regulation 12(4)(a) provides an exception to the duty to disclose information when information is not held.

Could you tell me how many individual Tree Preservation Orders are currently administered by the Council?

Could you tell me the date when the oldest TPO currently still valid was served?
