Dear Mr Gaffney,

Your request was received on 13 November 2018 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act'). You asked:

I am trying to establish the number of and percentage of students who are Scottish in each of your colleges and indeed your university as a whole.

This information is attached. Please note that the attached document should not be copied, reproduced or used except in accordance with the law of copyright.

The notes on the data are as follows:

- The numbers represent headcount of students who were active (not intermitting) as at 3 December 2018
- The numbers include matriculated students only (i.e. students who are members of the University and a college); non-matriculated students on credit bearing courses e.g. at the Institute of Continuing Education are not included
- The numbers exclude incoming exchange and other visiting students
- Scottish students are identified as those whose country of permanent address (domicile)
 prior to the start of the course is recorded on our central student records system as Scotland

If you are unhappy with the service you have received in relation to your request and wish to make a complaint or request an internal review of this decision, you should contact us quoting the reference number above. The University would normally expect to receive your request for an internal review within 40 working days of the date of this letter and reserves the right not to review a decision where there has been undue delay in raising a complaint. If you are not content with the outcome of your review, you may apply directly to the Information Commissioner for a decision. Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints
