CHARITY COMMISSION

In the matter of the following Charities called The Almshouse Charities of William Hickey and Others, being four of the Richmond Charities, in the former Borough of Richmond, in the London Borough of Richmond upon Thames, regulated by a Scheme of the Charity Commissioners of the 5th August 1974:-

1. The Charity called William Hickey's Almshouse Charity;

The Charity called Bishop Duppa's Almshouse Charity;
The Charity called Houblon's Almshouse Charity; and

4. The Charity called Sir George Wright's or Q

Elizabeth's Almshouse Charity; and

In the matter of the following Charity, at Richmond, in the said London Borough, regulated by a Scheme of the Commissioners of the 21st August 1974; and


5. The Charity called Michel's Almshouse Charity (including Benn's Walk Almshouses); and

In the matter of the Charities Act 1960.

THE CHARITY COMMISSIONERS FOR ENGLAND AND WALES HEREBY ORDER that the following Scheme be approved and established:-

SCHEME

1. Administration of Charities. (1) The Charity numbered 5 above shall be administered and managed as one of the above-mentioned Almshouse Charities of William Hickey and Others, which shall henceforth be referred to together as the Richmond Charities' Almshouses.



- (2) The Charities numbered 1 to 5 above shall be administered and managed in conformity with the provisions of the above-mentioned Scheme of the 5th August 1974, as varied or affected by the provisions of this Scheme.
- 2. Variation of Scheme. Clauses 33 and 34 of the said Scheme of the 5th August 1974 shall cease to have effect, and the following clauses shall be substituted therefor:
 - 33. General qualifications. The almspeople shall be needy aged persons, of whom 16 shall be persons appointed irrespective of any geographical limitation with regard to their place or former place of residence, and the remainder of whom shall be persons who are resident in the area of benefit at the time of appointment, or who, in exceptional cases at the discretion of the Trustees, are resident elsewhere but who have resided in the area of benefit at any time for not less than five years in the aggregate.
 - 34. Religious qualifications. When appointing almspeople the Trustees shall as far as possible ensure that not less than one half of the almspeople shall be members of the Church of England or persons who have been brought up and instructed in the Protestant religion.
- 3. Questions under Scheme. Any question as to the construction of this Scheme or as to the regularity or the validity of any acts done or about to be done under this Scheme shall be determined by the Charity Commissioners upon such application made to them for the purpose as they think sufficient.
