Teachers' Pension Scheme – Freedom of Information Request

Thank you for your emails dated 30 June and 23 July 2019 requesting information about establishments that have notified Teachers' Pensions of their intention to withdraw from the Teachers' Pension Scheme (TPS).

I have dealt with your request under the Freedom of Information Act 2000.

The list of establishments that have written to the scheme administrator, Teachers' Pensions, notifying them of their intention to withdraw from the scheme since 1 September 2018 is provided within the annex. This list is broken into two parts, those that informed the Secretary of State of their intention to withdraw between 1 September 2018 and 31 March 2019, and those that informed the Secretary of State of their intention to withdraw between 1 April 2019 the date of this letter.
