Dear Vishal Wilde

I refer to your request where you asked:

- 1. How many awards of exceptional, high performing, achieving were paid to civil servants on the Fast Stream in performance pay rounds for the years 2018 and 2019.
- 2. The percentage of, and numbers of, civil servants assessed to be 'on trajectory' at their Fast Stream Development Trajectory Assessment for the years 2018 and 2019.
- 3. The percentage, and numbers of, civil servants assessed who pass their Fast Stream End of Scheme Assessment in the first instance, for the years 2018 and 2019.

I am writing to advise you that following a search of our paper and electronic records, I have established that the information you requested is <u>partially held</u> by the Cabinet Office.

1. Fast Stream and Early Talent put in place an HR information system for the 2019 End of Year (EOY) markings.

2019 End of Year outcomes

Historical information has not been transferred to the HR information system. Before 2019, data were manually collected centrally. The 2018 results should be looked at with caveat that the data is sourced from this administrative data set that has not been fully quality assured.

Please also note, from April 2018 the Cabinet Office brought in the introduction of four performance markings to provide greater differentiation between performance. Before this, there were three categories reported below.

- 2. Development Trajectory Assessments were introduced in August 2019. Development Trajectory Assessments are still underway and the results have yet to be collated. As such the data is not held.
- 3. The centrally managed Fast Stream was originally created as a four-year programme with the first intake starting in 2013. Our information on end scheme assessments, therefore, covers intakes from 2013 to 2016. The 2018 and 2019 intakes have not reached the end of their leadership development scheme so they have not taken their Fast Stream End of Scheme Assessment.
