I refer to your request where you asked:

My understanding is that the Fast Stream is funded by charging government departments for each Fast Streamer and their work. Please could you confirm that this is correct.

- 1. Please also give any information relating to any other major sources of funding for the Fast Stream (e.g. central funding from Cabinet Office).
- 2. Please could you also provide, for the last 10 years, the cost to departments for a Fast Streamer. Please include any information as to whether, during this time, different departments have had received significantly different rates (>10%).

I am writing to advise you that following a search of our paper and electronic records, I have established that the information you requested is <u>held</u> by the Cabinet Office.

- 1. That is not correct. The Fast Stream is an accelerated leadership development programme rather than a resourcing programme. At the start of each programme cohort, whether a 3 or 4-year programme, departments make a bid for a future pipeline of individuals they expect to need at the end of the programme. We recharge departments on the basis of those bids, irrespective of the number of Fast Streamers they may having sitting in their organisation undertaking their experiential placements at any given time. This is essentially an "investment" charge. Fast Streamer numbers employed at the start of a cohort will usually exceed those required at the end of a programme. This is to allow for attrition over the duration of the programme therefore an average cost per bid is not representative of a cost per individual.
- 2. Fast Stream is purely funded by re-charges to departments. We do not receive any other source of funding.

3. We are unable to provide costs to departments per Fast Streamer for the last 10 years as we do not operate on that basis as explained above. In addition, the centrally managed Fast Stream started recruitment in 2012 with the first intake in 2013. However, we have provided an average annual charge per bid per programme in the table below as the proportion of a particular cohort in any given financial year April to March as the Fast Stream programme cohorts commence mid-financial year (September/ October).
