So far as the process is concerned:

- Interim arrangements were approved under your delegated powers on 11<sup>th</sup> February 2010
- The outcome of the public consultation in July/August 2010 was reported to the South West Community Assembly Member's briefing on 10<sup>th</sup> February 2011
- A further presentation & report will be made to the Community Assembly meeting on 31<sup>st</sup> March 2011

- Subject to the agreement of the SW Community Assembly it is proposed to engage in further dialogue with the NT/RSPB around the possibility of a medium term lease being granted with a view to reporting the outcome back to a future Assembly meeting. Dependant on the outcome of that meeting and further consultation with yourself it would be proposed to report any proposed leasing arrangements which may emerge to cabinet for approval.

I have been in dialogue with Mr Fitzmaurice on this subject for quite a while and I'd be happy to provide further explanation if required.

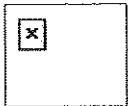
