Re: Freedom of Information Request – 58660

I am writing to request information under the Freedom of Information Act 2000. Under the Act, please disclose a list of all the flights that have left the UK after being chartered by the Home Office for the purposes of deporting and/or administratively removing people from the UK, for the period between 01/01/2016 to 09/04/2020.

Please include in this list:

- *the date on which each of these flights left the UK*
- *the number of people carried on each of these flights;*
 - *the number of individuals being returned by the Home Office*
 - *the total number of passengers listed on the manifest*

Your request is being handled as a request for information under the Freedom of Information Act 2000. We are now able to provide a reply to your request, which can be found in the attached annex.

If you are dissatisfied with this response to your Freedom of Information request you may request an independent internal review of our handling of your request by submitting a complaint within two months to foirequests@homeoffice.gov.uk, quoting reference FOI **58660**. If you ask for an internal review, it would be helpful if you could say why you are dissatisfied with the response.

As part of any internal review the Department's handling of your information request would be reassessed by staff who were not involved in providing you with this response. If you were to remain dissatisfied after an internal review, you would have a right of complaint to the Information Commissioner as established by section 50 of the FOIA.
