[REDACTED] has phoned Live Trackway (aluminium road supplier) and instructed them to remove the roadway or he will, see attached.

The roadway is required for access so should form part of the original conveyance agreement.

If you remember he made the same threat many months ago but never carried it out, from memory the DIT's solicitors got involved.

Yesterday afternoon I received a reply back from [REDACTED] which contained the following demands;

*In the absence of a meeting, the tenant would like me to ask that:*

- o *AMCO-Giffen stops parking vehicles on land rented by the tenant at the bottom of Station Road (between the station house and gate onto the GNRT), as you agreed to do when permission was granted to lay the aluminium trackway.*
- o *AMCO-Giffen stops using the land rented by the tenant at the bottom of Station Road (between the station house and gate onto the GNRT) as a loading/unloading area as this exceeds your access/egress rights over the property.*
- o *AMCO-Giffen removes the aluminium trackway from the tunnel's northern approach cutting.*

I'm assuming the DIT's solicitors will get involved again but can you confirm please.
