Freedom of Information Request

Thank you for your request for information about concrete roads dated 30 March 2021

We have dealt with your request under the terms of the Freedom of Information Act 2000.

You asked us:

In a HE press release today it mentioned that £400 million was being invested into concrete roads.

Please could I have the following information relating to this first concrete roads programme for 2021-2025

- What roads are being (or proposed to be) demolished and replaced. Please include the following information for each scheme: Road number, start and end points, distance, priority/expected start date, expected cost
- Are the roads getting demolished and replaced going to paved with concrete or Tarmac?
- What roads are being (or proposed to be) repaired. Please include the following information for each scheme: Road number, start and end points, distance, priority/expected start date, expected cost

We have tabulated the available information in response to the above request.

The table is divided into Reconstruction schemes (linked to 1) and Life Extension Works (linked to 3).

Demolition and replacement fit under options for Reconstruction schemes.

Repair and restoration are part of Life Extension Works.



Information requested in **2** is included after the requested information tabulated for the Reconstruction schemes.

The content of the Reconstruction schemes and Life Extension Works tables are provisional.

It is being reviewed and developed following the recent appointments on the Reconstruction Framework and the Lifecycle Extension Works Framework.

Forthcoming framework activities include scheme surveys, design, prioritisation, allocation of funds between the schemes, programming and road space booking. This will either confirm or clarify the provisional information which we are able to provide below.

The Reconstruction schemes are required to undergo a whole life analysis of pavement construction options and meet current Highways England standards for a 40-year structural design life. The standards permit various pavement construction options; including concrete and tarmac (asphalt).

The road surface material selection for the Reconstruction schemes include additional performance requirements to the underlying pavement construction. The road surface materials will typically be an asphalt surface course for Reconstruction schemes.
