Dear Mr Zacchi,

Thank you for your email of 07 November 2021 in which you requested the following:

Could you provide a list of the following:

A:

A1: Current Cadet Training Teams (CTTs)

A2: HQ/Location of the above teams

A3: Next above command/formation of each team (ie: which Brigade/Command does each report to (and/or commander))

B:

B1: Any CTTs which have disbanded in/since 1989 (to 2020)

B2: For the disbanded CTTs, their HQ/Location

B3: When were each of the CTTs disbanded, and which CTT took over that areas' duties?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (the Act). I can advise that information related to part A of your request is held by the department and is provided in the table at Annex A of this letter.

Information relating to part B of your request, regarding CTTs which have disbanded since 1989, is not held by the department. Under Section 16 of the Act (Advice and Assistance) I can advise that, whilst there will have been some structural changes involving CTTs since 1989, it is understood that none have been 'disbanded'. CTTs will have been re-organised and subsumed by the relevant Regional Brigade. I can also advise that, given the age of the information you are requesting, it is unlikely that such material dating back to 1989 will be held by the Department. Depending on the type of information being requested, after defined periods it will either be disposed of or potentially transferred to The National Archives for permanent preservation. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
